“High 5 for Mom & Baby” Updates – Gwen Whittit, Program Coordinator shared an overview of the program. To date 63 hospitals have enrolled, 47 have been “recognized” and seven have become “Baby-Friendly” designated. Gwen announced the new “Premier” program which recognizes hospitals who do not have the time or resources to become “Baby Friendly” but have completed parts of the “10 Step to Successful Breastfeeding.”
