## CONSTITUTION CORNER

### When Will We Hold Them Accountable to Their Oath?

Consider the duty of elected officials to follow their Oath to the Constitution. America became great, not because of what government did, but because of what government was prevented from doing by the Constitution. If the Constitution were accorded the importance it deserves, the federal government would be 20 percent its size and 20 percent its cost — and we would have 50 states whose laws more closely align with the mores and the desires of their populaces, a freedom that Americans in general should seek.

1. Article I, Section 1, Sentence 1: "All legislative powers herein granted shall be vested in a Congress of the United States."



The word "all" leaves no room for exceptions. In this instance, therefore, no government entity, individual, or group has been awarded any lawmaking power except Congress. But commonly employed presidential executive orders have been allowed to assume lawmaking status — which is obviously unconstitutional. Hundreds of executive mandates handed down by presidents over recent years have immediately been elevated to law governing the American people and their endeavors. The president may issue executive orders that should concern only how members of the executive branch function in order to comply with federal law, but he cannot change or make law. If a presidential executive order establishes a law governing the entire nation, the president has over-stepped his bounds, and his edict should be disregarded.

2. Article I, Section 8, Clause 1: "The Congress shall have power to ... provide for the ... general welfare." In this portion of the Constitution, the Founders meant only power toward establishing and maintaining general (national) conditions that would enable the people to start a business, invest in some enterprise, apply for a job, etc. The "welfare" they referred to was not the well being of individual persons; it was the "general welfare" of the nation itself. The Founders mocked our now-common view. James Madison said: "If Congress can do whatever in their discretion can be done by money, and will promote the General Welfare, the government is no longer a limited one, possessing enumerated powers, but an indefinite one, subject to particular exceptions."

Pro-life Americans could be excused for overestimating the importance of recent changes on the U.S. Supreme Court. They have endured one of the most mind-numbing legal battles in the history of modern man, arguing that it shouldn't be legal for a medical professional to murder tiny human beings while being consistently thwarted by supposedly friendly judges who seem intent on maintaining an immoral, unscientific, unconstitutional and outdated status quo and horrific jurisprudence,

I don't fault the euphoria that existed in pro-life circles when the Supreme Court looked to be restocked with Federalist Society-approved, constitutionalist judges, who could finally do to the dreadful *Roe* ruling what a previous Court had done to the dreadful *Plessy* ruling: overturn it, rectify it, and judicially apologize for their predecessors having screwed up so badly an issue of basic morality and humanity.

Most Federal Spending Occurs Without Congressional Approval: GAO

Given the ferocity with which federal lawmakers battle over the budget, one might think the fate of the entire country hung in the balance. But the truth of the matter, according to a new Government Accountability Office (GAO) report published November 29, is that they are fighting over a very small — and shrinking — portion of federal spending while most of the real budget-busters are on auto-pilot. Of the \$3.7 trillion Uncle Sam spent in 2015, the GAO found that \$3.2 trillion of it was spent without explicit congressional authorization. That means Congress voted on just 14 percent of all federal outlays that year. How did that happen when the Constitution vests the power of the purse in Congress alone?

The answer is that Congress has seen fit to take most spending decisions out of its own hands. Primarily, it has done so by creating entitlement programs whose budgets are determined by who is eligible to receive benefits and at what levels. These are known as “permanent appropriations.” The Department of Health and Human Services, which oversees Medicare, had the largest spending authority and permanent appropriations in 2015: \$979 billion, or about 30 percent of all such spending. The Social Security Administration came in a close second with \$928 billion, or 28 percent. The Treasury Department was next with \$542 billion, or 17 percent, most of which went to pay interest on the national debt.

All told, permanently funded programs accounted for \$2.6 trillion, or 70 percent of all spending. Congress has also ceded its power to federal agencies in other ways, including offsetting collections, contract authority, and borrowing authority, all of which allow agencies to disburse cash without an appropriation. Representatives and senators need to reclaim spending decisions from unelected bureaucrats as required by the Constitution. Then they need to follow the rest of that document and

## In America Today, We Plunder and Call It Good

Frederic Bastiat, a French economist and member of the French National Assembly, lived from 1801 to 1850. He had great admiration for our country, except for our two faults—slavery and tariffs.

He said: “Look at the United States. There is no country in the world where the law is kept more within its proper domain: the protection of every person’s liberty and property.”

If Bastiat were alive today, he would not have that same level of admiration. The U.S. has become what he fought against for most of his short life.

Bastiat observed that “when plunder becomes a way of life for a group of men in a society, over the course of time they create for themselves a legal system that authorizes it and a moral code that glorifies it.”

You might ask, “What did Bastiat mean by ‘plunder’?” Plunder is when someone forcibly takes the property of another. That’s private plunder. What he truly railed against was legalized plunder, and he told us how to identify it.

That could describe today’s American laws. We enthusiastically demand that the Congress forcibly use one American to serve the purposes of another American. You say: “That’s insulting. It’s no less than saying that we Americans support a form of slavery!”

What then should we call it when two-thirds to three-quarters of a \$4 trillion-plus federal budget can be described as Congress taking the property of one American and giving it to another to whom it does not belong?

What if I privately took the property of one American to give to another American to help him out? I’m guessing and hoping you’d call it theft and seek to jail me. When Congress does the same thing, it’s still theft. The only difference is that it’s legalized theft.

However, legality alone does not establish morality. Slavery was legal; was it moral? Nazi, Stalinist, and Maoist purges were legal, but were they moral?

Some argue that Congress gets its authority to bypass its enumerated powers from the general welfare clause. There are a host of proofs that the Framers had no such intention.

James Madison, the “Father of the Constitution,” wrote, “If Congress can do whatever in their discretion can be done by money, and will promote the general welfare, the government is no longer a limited one possessing enumerated powers, but an indefinite one.”

Thomas Jefferson wrote, “Our tenet ever was ... that Congress had not unlimited powers to provide for the general welfare, but were restrained to those specifically enumerated.”

Rep. William Drayton of South Carolina asked in 1828, “If Congress can determine what constitutes the general welfare and can appropriate money for its advancement, where is the limitation to carrying into execution whatever can be effected by money?”

What about our nation’s future? Moral Americans are increasingly confronted with Bastiat’s dilemma: “When law and morality contradict each other, the citizen has the cruel

alternative of either losing his moral sense or losing his respect for the law.”

## The Road From Abortion to Infanticide, Euthanasia

A Democratic senator blocked on Monday night the Born-Alive Abortion Survivors Protection Act, which would have ensured child-



ren who survived abortions were given medical care. This Act

came on the heels of comments last week from Democratic Gov. Ralph Northam of Virginia insinuating that he supports infanticide in some instances.

Roe v. Wade legalized abortion by implicitly categorizing an unborn baby as the “personalty” or one’s private property. Thus, ironically, merely a few years after America’s affirmation of the civil rights movement, the Supreme Court majority in Roe declared that there was, after all, an entire class of human beings—unborn babies—for whom there would be no guarantee of justice and equality.

Justice John Paul Stevens supported the perverse logic of Roe by arguing that an unborn baby does not become a human being until the moment of birth. Furthermore, as Valparaiso University law professor Richard Stith argued 20 years ago, the incoherence of this progressive argument—that the moment of birth is a “bright line” at which an infant becomes a human being—may very well lead to the embrace of infanticide.

In other words, since medical science makes clear that there is very little difference between a baby the day before birth and the day after birth, Stith speculated that progressive thought leaders would increasingly argue for the legalization of post-birth abortion.

John Harris, a founder of the International Association of Bioethics, argues that if abortion can be justified, so can infanticide.

Similarly, Jonathan Glover, senior ethicist at King’s College London, argues that there is no such thing as an inherent “sanctity of human life.” He argues that babies are not autonomous because they are not even aware of the difference between life and death. Thus, parents and medical personnel should evaluate whether or not the infant’s life is worth living.

Even worse is the inevitability that the movement to legalize infanticide will be accompanied by a push to legalize euthanasia and physician-assisted suicide.

Anti-life legislation is arguably the most consistent consequence of the culture of death enshrined in our legal code since Roe v. Wade. Northam and Murray represent a powerful movement to stay true to the ethic undergirding pro-abortion activism, and they are gaining support day by day.

This unashamed movement to undermine the sanctity of human life must be resisted, not only by Congress but also by the citizens of our great nation.
