### OMICRON CRACKPOTS

Joe Biden said yesterday people should get vaccinations and booster shots to ward off the

Do you want to follow the science or follow the government pied pipers who, themselves, might just be following the money?

Speaking of science, there are a hundred studies showing masks are not materially effective in reducing COVID transmission and are actually harmful to wear.

So much for the mask narrative, but the wheels are coming off other government narratives about COVID, too. 'The vaccines are effective' - no, breakthrough cases are on the rise as vaccine efficacy drops below 50 percent.

They said close the schools even though the risk to kids was minuscule and closing schools didn't lower the child mortality rate. They ignore natural immunity and kept pushing the vaccines even though almost 150 million Americans have natural immunity from having been exposed to coronavirus.

### Ivermectin Shows 'Astounding' Results Against Coronavirus

Reports Friday from multiple trials in the United States and abroad indicate a drug already approved by the FDA to treat parasitic infections is showing "astounding" results, and could represent a breakthrough in efforts to vanquishing the SARS-CoV-2 virus at the heart of the global pandemic.

Doctors have administered Ivermectin in several simultaneous trials in several countries sometimes in combination with other common medications.

Physicians who participated in the study report that patients' viral loads began declining almost immediately after they began administering Ivermectin, a widely available prescription drug approved to combat parasites, scabies and head lice.

It has not been approved for COVID-19 patients, but doctors familiar with clinical trials described patients' results as dramatic.

Emergency medical physician Dr. Peter H. Hibberd, M.D., of Palm Beach County, Florida, told Newsmax in an exclusive interview that he's optimistic the drug will prove to be an important therapeutic advance, although he expects more trials will be needed before it wins FDA approval for use as a COVID-19 medication.

He noted it has impressed doctors in clinical trials on multiple continents.

"There's a common denominator here," said Hibberd. "This drug is salvaging people from their death bed."

In some cases, doctors reported just one dose of Ivermectin markedly improved a patient's condition. US patients received a single oral dose, and some of them received a booster dose seven days later.

The drug first emerged as a possible coronavirus therapeutic after a study by researchers in Victoria, Australia showed the drug wiped out the virus in a test tube.

On Thursday, a team of U.S. doctors led by Dr. Jean-Jacques Rajter at the Broward Health Medical Center in Fort Lauderdale, Florida, submitted findings to an institutional review board. According to a medical source familiar with the study, some 250 coronavirus patients were involved in the Broward trial. The results were dramatic, with "statistically significant improvement in mortality," according to the source.

The blood oxygen level of the first patient treated in early April was 70%, and dropped to just 50% within hours. After receiving the Ivermectin, the patient stabilized within 24

hours and was discharged from the hospital in one week.

It is important to note that while some patients are receiving the medicine on an emergency basis, the FDA on May 1 posted the following advisory: "While there are approved uses for Ivermectin in people and animals, it is not approved for the prevention or treatment of COVID-19. You should not take any medicine to treat or prevent COVID-19 unless it has been prescribed to you by your health care provider and acquired from a legitimate source."

In a separate trial on the other side of the globe, a team of doctors in Bangladesh reported Friday that they administered a combination of Ivermectin and Doxycycline, a common antibiotic, to 60 coronavirus patients there.

That team reported that within 72 hours after receiving the drug, their patients tested negative for the virus, and by the fourth day, they had recovered. Dr Tarek Alam, a senior doctor for the Bangladesh Medical College Hospital, told India's ZeeNews that the results were "astounding" and said all patients "experienced full recoveries."

One reason the FDA is cautious is that the drug can interact with other medications, and in some cases can cause complications such as nausea, diarrhea, stomach pain, dizziness, a sudden drop in blood pressure, liver problems and other side effects.

The Gates Foundation is funding a third clinical trial of Ivermectin in France, according to TrialSiteNews.com.

Hibberd said the Ivermectin trials indicate it is an "effective therapy" that would provide a bridge to a vaccine and would potentially reduce the downside risk of catching the virus.

"It would mean we could go to work and not worry," he said of the prospect of having an effective therapeutic medication. "You catch it, we treat you and we move on as a country." (Note: Heartland Herald makes no claims about Ivermectin, and urges patients to check with their doctor before using)

This is a difficult message to deliver because it deals with so many of today's churches that have been built on crumbling foundations based on worldly concepts. You may know about King Nebuchadnezzar's dream of a giant idol a head of gold, arms and chest of silver, a body and thighs of brass and feet of iron mixed with soft clay. In the end, the feet will be shattered, and the idol would fall. The dream dealt with kingdoms, but the analogy also applies to modern "churchianity."

From the raising up the first Christian churches in the days of the apostles, until these times approaching the end of man's misrule, the iron strength God's word has become mixed with the clay of man's desires. The foundations become weakened to the point of collapse and God's ordained commission of delivering the pure gospel and making disciples of believers is abandoned.

What does this diluted religion look like? Divisions caused by false teachings and internal squabbles put the promise of eternal life in peril for many who fill the pews searching for God's wisdom. Tragically, there are pastors who are more concerned about keeping their 501(c)3 tax exempt status or who are afraid of offending and losing some of the flock. They preach sermons made to please those with itching ears.

In this election year America finds itself on the edge of an ungodly socialist/communist takeover. Where are the sermons warning against selecting leaders steeped in such ideology? "Wait," you may say, "my pastor says we are not of this world and have no business being involved in the politics of voting."

Really? Here is just one of many scriptures belying that mindset. *"Furthermore, you shall select out of all the people able men who fear God, men of truth, those who hate dishonest gain; and you shall place these over them as leaders of thousands, of hundreds, of fifties and of tens. (Exodus 18:21)*

There are ways to serve God's people without supporting one candidate or party over another. The above verse makes it plain what we are to look for in selecting those who exercise control over our lives and property. Here are some sound principles:

- *Never* endorse any particular candidate or party, but it can be helpful to provide sample unmarked ballots to determine the choices to be made.

Pastors, above all, remember your church is NOT the building, but rather the men and women of your congregation. As a shepherd, your responsibility is to guide and protect the flock, not by using smoke and mirrors, but with scriptural motivation. Elections have consequences among which is the loss of religious freedom.

As the Apostle Paul warned, *"Be on guard for yourselves and for all the flock, among which the Holy Spirit has made you overseers, to shepherd the church of God which He purchased with His own blood."* Acts 20:28-32



## NUREMBERG CODE MAKES VACCINE CONSENT ESSENTIAL

The first mandate listed in the “Permissible Medical Experiments” section of volume II of the Trials of War Criminals reads: “The voluntary consent of the human subject is absolutely essential.” That’s it then, right?



Shouldn’t Biden be locked up as a war criminal? After all, he’s been calling for forced vaccines. During Military Tribunals in Germany following World War II, Nazi doctors and medical administrators were tried for atrocities committed during the holocaust.

To prevent a repeat of the evils perpetrated on humanity, the judges outlined 10 conditions for permissible medical experiments in the future that became known as the Nuremberg Code. Its adoption into the 1949 Geneva Conventions later gave the 1947 Code international standing. Breaking from the Convention’s intent presumably constitutes a war crime. Thus, with COVID jabs being forced on unwilling participants, we ought to at least understand what the Nuremberg Code is about.

Some fact-checkers, as is often the case, are basing their Nuremberg Code vaccine arguments on opinion. Take USA Today, for example. Once a respected news organization, they’ve now jumped on the lucrative bandwagon of having in-house “fact-checkers.”

An article published on August 10, 2021, attempts to discredit one FB user’s claim that forced vaccinations go against the Nuremberg Code. USA Today’s fact-checkers state that “The claim that ‘forced’ vaccines are against the Nuremberg Code is FALSE, based on our research.” Notice they aren’t discrediting that vaccines are covered under the Code. Simply that the current forced vaccines aren’t illegal.

But where is their proof that “Americans who get vaccinated against COVID-19 are not part of an experiment.” Or that “[t]he vaccines have been tested in clinical trials and found to be safe and effective.” I couldn’t find it.

Their main source justifies the record speed of the vaccine by the “layering” of trials made possible by advancements in technology, an abundance of funding, and the relaxing of bureaucratic regulations. That’s all well and good, but nowhere does the fact-checkers’ source state that the resulting vaccine was proven safe and effective.

My research has discovered quite the opposite. While the jabs were indeed approved for emergency use authorization, such status is normally reserved when no other treatments are available. Per the FDA’s own website, they “may authorize unapproved medical products … to be used in an emergency to diagnose, treat, or prevent serious or life-threatening diseases or conditions … when … there are no adequate, approved, and available alternatives.” (Emphasis mine.) COVID-19 did have several “adequate, approved, and available alternatives.”

There are effective outpatient treatments, “including monoclonal antibodies such as Regeneron and intracellular anti-infectives including hydroxychloroquine.” He is also a big proponent of Ivermectin. McCullough added: “What frustrated me, was in the media cycle, all we heard about was reducing spread, and then later on vaccination. We never actually heard about treating sick patients. Had there

been more of a focus on treating sick patients, early treatment could have prevented up to 85% of COVID deaths.”

Instead, he said, there’s an “incredible suppression of early treatment in the medical literature.” He’s hardly the only one speaking out. America’s Frontline Doctors, the mRNA inventor of the vaccine technology Dr. Robert Malone, Nobel Prize nominee and world-renowned “Physician of Presidents” Dr. Vladimir Zelenko have all risked their livelihoods and fortunes to get the truth out.

Heavily censored and ridiculed, these whistleblowers have collectively saved scores of people with their successful treatment plans. So just because social media controllers have shaped the narrative that treatments are non-existent doesn’t make it true. And simply because vaccines have been approved for EUA means little when the very alternative, and inexpensive, treatments for COVID have been banned.

Which returns us to the original question of whether the vaccines are experimental, as the above-mentioned fact-checkers deny. Nuremberg Code Principle #1 makes clear that the recipient of a medical treatment “should have sufficient knowledge and comprehension … as to enable him to make an … enlightened decision.” And that, “there should be made known to him the nature, duration, and purpose of the experiment … and the effects upon his health or person which may possibly come from his participation in the experiment.”

Were vaccine recipients provided such “knowledge and comprehension” about the effects before getting the jab? In an in-depth research article, I published on April 28, 2020, I exposed that “an April 16th Press Release on the Gates-funded Moderna’s website announced that ‘no commercial product using mRNA technology has been approved before and the safety and efficacy of mRNA-1273 has not yet been established.’” In other words, human beings would become the experimental guinea pigs for the ultimate “safety and efficacy of mRNA” technology.

According to Smithsonian Magazine, “in July [2020], both Moderna and Pfizer/bioNTech began studies of their mRNA vaccines in about 30,000 people apiece, hoping to show their vaccines are safe in large groups.” Those results were, supposedly, released in November — a mere four months after the first studies in humans began. Seems awfully convenient that the testing was deemed adequate for mass distribution just as the waning immunity now known was about to become discovered.

And so, it was with the rush to get a COVID-19 vaccine into the arms of human test subjects paralyzed by the fear from the left’s lies that there were no other treatment alternatives available. Experts agreed even then that the normal time to bring a vaccine to market safely is 10-15 years, as Heritage.org reported in April 2020. They stressed that, “[b]efore a vaccine can be tested in humans, it’s investigated carefully in a lab. This step usually involves animal trials, but regulators have allowed researchers to skip this step to fast-track development of a SARS-CoV-2 vaccine.”

A third point in Principle #1 of the Nuremberg Code states that “the person involved should … be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion.” For those who understand the deception behind the vaccine’s rush to market, our final outrage is our looming loss of freedoms. Those who have done our research trust no Facebook bought-and-paid-for fact-checker to convince us that these experimental jabs are safe or deserve the Emergency Use Authorization designation they’ve been so hastily given. Perhaps fact-checkers should instead focus on

the tenets of the Geneva Convention, which state that the rules pertain to war-time atrocities. Then the argument becomes whether we are being experimented on during a state of war. Now that’s an argument worth having.

## HOW TO REACH YOUR CONGRESSMEN

On page 8 the Heartland Herald has again printed the contact phone numbers for your Florida Legislation Delegation. For contact information outside of the State, see the following guidelines:

According to *iVoterGuide*, every voter will have three members of Congress to contact: The two U.S. Senators from the voter's respective states and the Representative from the voter's district. Their contact information can be found by using the following links:

House:

Senate:

**iVoterGuide** suggests:

**1. Call the Direct Number.** If possible, learn the direct number to your representatives' offices rather than calling the switchboard. When you call directly, your number is displayed on caller ID. Simply put, elected officials generally care what you think because they need your vote. A staff quickly learns area codes and is more likely to take the call when they see it is from their district/state.

**2. Identify as Being from their District.** No matter how you are contacting your Congressperson, always start by giving your zip code so the office knows you are in the district. If you do not live in a Member's district, it is best to rally your friends who *do* live in the district rather than calling them yourself. If you need to leave a message, don't hesitate to do so – but don't forget to leave your zip code. As staffers listen to messages, they will tally the yes and no responses from people in the district, and the information will be passed on to the Member. You can fax! Some offices still have fax machines that are rarely used. Sending a fax can be a great way to reach those offices.

**3. Be Specific.** Be as specific as possible about what bill/issue you are referring to and how you want them to vote. Brief is not bad. "I'm John Smith, a constituent in zip code ----, and I'm calling to ask the Congressman to please vote no on H.R.1" is perfectly fine.

In most cases, the *reason* you oppose or support a bill is not relevant to your Member. It is all about the numbers. At their best, Congresspeople are trying to represent the voters in their district, but now is not the time, for example, to try to convince your Member *why* they should be pro-life if they aren't. The goal is for enough calls to come in regarding specific legislation that your Member believes could affect the outcome of his next election.

**4. Be Timely.** Your Congressperson's office is fielding so many calls that they have to find a way to prioritize. **Call them when a bill addressing your issue is before the body.**


**5. Be Nice.** Remember that you will be speaking with staff or even an unpaid intern who might not even share the views of the Member. They also may be getting hundreds or thousands of calls. Respect, civility, and even kindness go a long way. People can rise very quickly in congressional offices. The staffer you talk to today might be the Chief of Staff next time you call, and they will remember who was nice to them when they were first starting out. Learn names. Take every opportunity to build a relationship. Being nice is also the best marketing any cause can have!

Issues and stances are fairly judged by the people who espouse them. Be a light for your values – and for God.

**6. Say "Thank You."** Don't just call when you are upset. If a member voted how you wanted them to vote, call back to thank them. We often only use the "stick" to try to motivate our Congress people and forget that the "carrot" goes a long way, too!

**7. Remember**, you always can write out what you want to say, and have other paperwork in front of you to use as reference if you need it. Nobody can remember everything. So, if you have bill numbers plus your thoughts and observations in front of you, it helps to make you more able to express yourself and gives you additional confidence. Remember - Congress people work for US!

## Pennsylvania Supreme Court Ends School Mask Mandate



Department of Education hosts mask-free event as state battles to keep masks on kids

The Pennsylvania Supreme Court Friday affirmed a Commonwealth Court decision that said Acting Health Secretary Alison Beam did not have the authority to issue a mask mandate for everyone indoors at schools and childcare centers.

It means, effective immediately, school mask mandates are no longer mandatory, although many schools have a local rule that students who wish to wear a mask may still do so.

The suit was brought by Pennsylvania Senate President Pro Tempore Jake Corman, a Republican who is running for governor. It was filed personally, as a parent, along with other parents, and not as part of a Senate action.

"With today's ruling, the power for parents and local leaders to make health and safety decisions in our schools is restored," Corman said in a prepared statement. "That power comes with an obligation to review the facts and act in the best interests of our communities—which is why legislative leaders sent a letter to Governor Tom Wolf yesterday to reconvene the COVID-19 Vaccine Task Force. I encourage all stakeholders to review the needs and conditions in our communities to make the best choices for our kids."

Wolf recently announced he would return masking decisions over to local school leaders on Jan. 17, so some were surprised when the state's Department of Health appealed the Commonwealth Court's decision and continued fighting for the mandatory mask mandate.

While the state battled in court to keep masks on kids, on Dec. 6, educators gathered without students and appeared unconcerned about masking.

The announcement was made during the Standards Aligned System Institute, the Pennsylvania Department of Education's annual professional development conference. Photographs from the event, provided by the state, show teachers and state employees gathered without social distancing and not wearing masks.



## LATINO VOTERS WALKING AWAY FROM DEMOCRATS LIKE A BAD SMELL

One year after giving Democratic House candidates more than 60% of their vote, according to polls at the time, the Journal survey found that Hispanic voters are evenly split in their choice for Congress. Hispanic voters were also evenly divided when asked about a hypothetical rematch in 2024 of the last presidential contenders, with 44% saying they would back President Biden and 43% supporting former President Donald Trump. In 2020, Mr. Biden won 63% support among Hispanic voters, nearly 30 points more than Mr. Trump, according to AP VoteCast, a large survey of the presidential electorate.

Evenly split? 37%-37% with 22% up for grabs? That's really bad news for Democrats.

Democrats view America's 62 million Hispanics as "theirs" because many big states -- Florida, Texas, California -- have huge percentages of Hispanics in their populations -- 26%, 39%, and 39% respectively. Hispanics account for a fifth of the American population now, and one out of eight voters. I was there at the 2008 Democratic National Convention in Denver and know that Democrats were convinced that Hispanic voters would always be "theirs."

The problem they hadn't counted on is that their agenda stinks to Hispanics. They never had a clue as to what Hispanic voters were thinking

Open borders? Democrats were convinced that all they needed to do was throw that at Hispanic voters and they'd be happy.

Open borders, in fact, generally repel Hispanic voters, given that such voters know that letting in millions of unvetted migrants, some of whom are undoubtedly the very criminals they wanted to get away from when they moved to America, and others of whom know that illegals price them out of job markets by working under the table, and undercut legal worker wages which would mean them. ## CONTINUITY OF GOVERNMENT AND DEVOLUTION – PART 2

In the December edition of the Heartland Herald, we introduced Continuity of Government, the long-time planning tool developed in the post war 1950's by President Dwight D. Eisenhower. When President Trump departed Joint Base Andrews on January 20, 2021, after exhausting all apparent available pathways of appeal for a corrupt election, and thus the criminal takeover of our government was he just walking away? Would he let the political establishment rob the American people and get away with its crimes without a real fight? It is important to study Trump's awareness of all that was traitorously being planned and see his preemptive and on-going actions up until the present day.

In the previous article, we described Presidential Policy Direction 40 (PPD-40) signed by President Obama in July of 2016. All agencies of government were ordered to have not just a planned line of succession but also one of "devolution", a duplicate chain of individuals secreted outside Washington DC available in a catastrophic national emergency.

Devolution may involve "procedures for transfer of statutory authority and responsibilities" to a secondary designated staff ordered to sustain essential functions of government.

Devolution plans initiated by President Trump were deemed necessary when a government failure was recognized. This was done as designed through the military and the Department of Defense. It became apparent that the nation faced multiple acts of war upon its sovereignty. We are presently engaged in a war! Not a war involving thousands of troops clashing on a battlefield, but one more clandestine in nature. It involved cyber warfare, information warfare, electronic warfare, intelligence warfare, space warfare and even biological warfare (COVID) and the involvement of other nations. PPD-40 is still classified but Federal Continuity Directives from FEMA were created from it. On December 7, 2020, Trump issued an Executive Order that explains it is the policy of the United States to perform 8 National Essential Functions in a continuity environment, regardless of outside threat or emergency conditions.

From a Newsweek article published on March 18, 2020, "Above-Top Secret contingency plans already exist for what the military is supposed to do if all the Constitutional successors are incapacitated. They are so secret that under these extraordinary plans, "devolution" could circumvent the normal Constitutional provisions for government succession, and military commanders could be placed in temporary control around America."

The Newsweek article claims, "Standby orders were issued more than three weeks ago to ready these plans...." That means that Trump had ordered the military to review and prepare the Continuity of Government plans in February 2020. (See Continuity on page 8)

On December 7, 2020, Trump issued Executive Order 13961 titled - Governance and Integration of Federal Mission Resilience (FMR). It stated, "It is the policy of the United States to maintain comprehensive and effective continuity programs that ensure national security and preservation of government structure under the United States Constitution and PPD-40 of July 15, 2016. Executive department and agencies including the Executive Office of the President must maintain the capability and capacity to continuously perform National Essential Functions (NEFs), regardless of threat or condition, and with the understanding that adequate warning may not be available.

The FMR Executive Committee is responsible for development of the plan of continuity, but also facilitating the execution of that plan of continuity.

Presidential Emergency Action Documents (PEADs) are executive orders, proclamations, and messages to Congress prepared in anticipation of a range of emergency scenarios, so that they are ready to sign and put into effect the moment one of those scenarios comes to pass.

As part of the original Eisenhower Administration continuity of government plans, these PEADs can be used in other emergency situations where normal operation of government is impaired.
