COVID: Sky Refuses To Fall

The press and the COVID narrative pushers in the Biden administration are running around yelling ‘the sky is falling, the sky is falling’, but the sky refuses to fall. So you can say the delta variant justifies mandatory vaccinations in the military or for California teachers, but you can’t make a case that holds water.

Let’s compare apples to apples, shall we? I have used one number consistently throughout my commentary on this subject - the official CDC number for the percentage of emergency room visits nationwide represented by COVID-19-like illnesses. That number spiked to 8.7 percent around the first of the year. Two months ago, it was at a low of 0.7 percent.

It peaked at 5.3 percent August 4th through August 8th, but dropped back to 4.9 percent on the 9th, the last date for which numbers are available. The number is well below a pandemic high. No, the sky is not falling. You can’t make that case.

There’s another number I’ve used consistently, the official CDC statistic for the number of Americans dying from adverse reactions to COVID vaccines. That number now stands at 12,532, up more than a thousand from just two weeks ago, according to official CDC numbers for adverse reactions. OpenVAERS So you read all these articles about how only the unvaccinated are going to the hospital, but maybe the numbers are skewed.

Maybe we have 12,000 people who dropped dead from the vaccine before they ever got to the hospital. One thing’s for sure: every story, every journalist, every public health official, and every politician who says you have to get vaccinated, because the sky is falling, is lying to you. NONE of them is talking about the thousands of people who have died from the vaccine itself. Until they do, I’m not listening.

You can put on top of that the increasing number of break-through cases - people who get sick with COVID despite being fully vaccinated. There were over 120,000 break-

through cases by the beginning of the month. The government has conveniently stopped counting the total number because it doesn’t fit the narrative. Now they are only counting breakthrough hospitalizations and deaths.

And we still have public health officials cooking the books and inflating COVID numbers. The CDC combined multiple days of data into one, helping the complicit media report a record number of COVID cases in Florida on a particular day earlier this month. After the state health department called them out, the CDC quietly cut the number by a third. No more record, the sky is not falling. A Texas news outlet wrongly reported there were 5,800 children hospitalized with COVID in a week’s time. They later issued a correction, chopping the number down to 783 over 40 days. Oops, so sorry. No, the sky is not falling.

Then we have Arnold Schwarzenegger telling everyone to mask up because the sky is falling - “screw your freedom,” he says. Well, Arnold, the sky is not falling. If you think cloth masks protect you and others from microscopic viruses, I cordially invite you to make your case for taking my freedom away from me. I will debate you anytime, anywhere. In the meantime, not only have I stopped listening to the Arnold Schwarzeneggers of the world entirely, but my contempt for them also grows by the day.



Parent Organization Sues Florida School District to Locate Alleged 'Very Pornographic' Children's Textbooks

A lawsuit has been filed against Broward County Public Schools (BCPS) in Florida after two public records requests were denied regarding a list of 42 books that the requestor believes have "very pornographic" content that may be available to children as young as 4 years old.

"The lawsuit was filed reluctantly but we had to say to Broward County that we need this information," Rick Stevens, one of the founders and co-managing directors of Florida Citizens Alliance (FLCA).

"We want to know what materials they have in their media centers and libraries," Stevens said, explaining that the two months of delays and excuses they faced to find simple answers begs one question: "What are they trying to hide?"

Floridians have a clear right to see those materials. FLCA is doing what any parent would do if they were concerned about what his or her kid is being exposed to in school."

One of the books on the list that FLCA submitted in 2019 has a drawing of a naked woman bent over forward holding a hand-held mirror to examine her genitalia.

The image described is in a book titled "It's

Perfectly Normal," recommended on Amazon for children "10 and up" in grades 5 to 8. Another image in the book depicts a man and a woman engaged in sexual intercourse.


"It's Perfectly Normal" wasn't on the 2021 list of books submitted to BCPS by FLCA, so FLCA doesn't know if that book is still being made available to 10-year-olds.

BCPS is still withholding exactly where in the schools the books they admit to having from the 2021 list are located: media centers, instructional materials, supplemental materials, or reading lists.

"Our parents send their children to school with the expectation that their children will get a good education and the school will take care of them," Stevens said. "Well, when the parents send their children to school, they have a reasonable expectation that the school is doing the same thing, monitoring the materials and making sure they are the right kind of things for their children to be exposed to."

BCPS finally provided a list Thursday, three days after filing the lawsuit, but they didn't provide all the information asked for.

The list BCPS provided shows which schools



the books are located in, but it doesn't specify where in the schools those books are located.

BCPS's stonewalling undermines Floridians' rights to access public records and that is why it's imperative that a public example be made of BCPS to show that government school districts can and should be held accountable for disregarding Floridians' rights to access public records."

Keith Flaugh, managing director of FLCA, said advocates of the inappropriate material are trying to accuse his organization of trying to "ban books."

"We're not banning books," Flaugh told The Epoch Times, explaining they are trying to prohibit the availability of inappropriate materials to minors. "It's not banning books any more than it's banning guns or drugs from school property. These are harmful materials, and our public schools have no place distributing or allowing them."


"These books are sexually explicit and age-inappropriate," Flaugh insisted, "and books like 'It's Perfectly Normal' are very pornographic."

Books such as "Sex, Puberty and All That Stuff," on the 2021 list of inappropriate books, teaches minor children aged 11 to 16 all about erections. "This Book is Gay" (also on the 2021 list) provides minor children aged 14-17 detailed instructions—including explicit drawings—on how to have "boy-on-boy" and "girl-on-girl" sex.

While BCPS admitted to having 82 percent of the books deemed inappropriate on their 2019 list, they now claim to have only nine of the books on the "inappropriate content" list for 2021. That's still nine books!

The most popular of the nine books is a young adult (YA) novel by Judy Blume called "Forever," originally published in 1975. According to Amazon, the recommended grade level for this book is "nine and up."

CDC Revokes COVID Test Emergency Use Authorization

CDC encourages laboratories to consider adoption of a multiplexed method that can facilitate detection and differentiation of SARS-CoV-2 and influenza viruses. Such assays can facilitate continued testing for both influenza and SARS-CoV-2 and can save both time and resources as we head into influenza season. Laboratories and testing sites should validate and verify their selected assay within their facility before beginning clinical testing.

This says it all. The RT-PCR tests could not differentiate between the flu and COVID. So again, the numbers are proven to be a lie.

Biden EO Provides Taxpayer-funded Gender-Transition Surgeries for U.S. Military

Taxpayers will soon foot the bill for gender reassignment surgery for America's service members in an order some fear will cost the nation in terms of both money and military readiness.

In January, Joe Biden issued an executive order that would allow transgender individuals to serve in the military – reversing a policy implemented by former President Donald Trump.

But deep in the language of that order was a clause that read, "The Secretary of Defense also concluded that it was appropriate to create a process that would enable service members to take steps to transition gender while serving." Thus, the order requires establishing a process by which transgender service members may transition gender while serving. Officials were given 60 days to implement the Jan. 25 order.

To that end, Sec. of Defense Lloyd Austin promised, in a statement released the same day, that his goal is "All medically necessary transition related care authorized by law is now available to all Service members."

Veterans' Affairs Secretary Denis McDonough in February mandated that the VA, "examine the entire slate of services in the department provided to veterans to ensure maximum equity and inclusivity, including the delivery of medically necessary, gender affirmation care and procedures." That's not going to be cheap.

The Philadelphia Center for Transgender Surgery collected data that shows multiple forms of gender reassignment surgeries for men and women typically amount to anywhere between \$100,000 to \$200,000 according to the Washington Examiner. In 2019, USA Today reported that the Pentagon spent approximately \$8 million on gender reassignment surgery costs for 1,500 transgender military personnel.

Republican Rep. Jim Banks of Indiana, a member of the House Committee of Veterans' Affairs, said, "there is a distinction between welcoming transgender individuals into the military and paying for gender reassignment surgery."

"This is a radical and new territory, for a presidential administration to force taxpayers to fund sexual reassignment surgeries for those in the military." Banks told the Examiner. "I'm compassionate toward those individuals who want to undergo surgery of this nature, but taxpayers shouldn't be on the hook to pay for it." It's constitutionally dubious that Congress hasn't passed these measures but the administration, in a radical way, is pushing through this agenda. I sit on the committee that should debate these issues."

One retired military man said the combat implications of the order are staggering. Lt. Gen. Thomas Spoehr, who commanded Army forces in Iraq and is now associated with The Heritage Foundation, said Biden's order makes it seem that going for gender reassignment could take precedence over combat.

"I would like to think the Pentagon would come up with a procedure. It's completely irrational to change your gender in front of a conflict," Spoehr said. "A lot of people (in the military) are outraged by this idea that (continued on page 6)

Biden Approves Financing Beijing's Military

China expert Gordan Chang, author of "The Coming Collapse of China" and a senior fellow at the Gatestone Institute, shares how Biden has reversed a Trump action that prevented Americans from financing China's military.

On January 26, The Treasury Department's Office of Foreign Assets Control issued a license permitting Americans to continue acquiring shares in certain companies associated with "Communist Chinese Military Companies," known as CCMCs, until May 27.

Trump's order "stopped investors, subject to wind-down provisions, from purchasing or possessing shares in any company designated a CCMC. In Short, Chang wrote, "Trump ordered Americans to stop financing China's military, The Peoples Liberation Army."

There are now 44 companies on the list, including Semiconductor Manufacturing International Corp., China's leading chipmaker and China's National Offshore Oil Corp. Biden's order, Chang said, essentially "guts"

Trump's order banning investment into dozens of companies that should be off limits.

"The Biden administration caved. Wall Street had fiercely opposed Trump's executive order and was given additional time for its repeal," Chang said.

Chang was told by Roger Robison, chairman of the Prague Security Studies Institute, that changing Trump's order, "would only serve to enrich Wall Street and Beijing at the expense of American security, fundamental values, and investor protection." "He's right," says Chang.

Beijing views the U.S. financial community as its channel to influence the highest levels of the American political system." The ban should cover all of China's government owned operations as well as privately owned companies." Chang insisted.

As President Trump wrote in the preamble to EO13959, "the national strategy of Military-Civil Fusion" means that the party-state compels private companies to support the "military, intelligence, and security apparatuses, and aid in their development and modernization."

you can just come in and get this (surgery) and be gone from your unit. Someone has to pick up the slack while you're gone."

Spoehr noted that other recruits who might need ongoing medical treatment are not accepted into the military and voiced his belief that many people might be tempted to join the armed forces simply to receive gender reassignment surgeries on the country's dime."

Tony Perkins, president of the Family Research Council and a U.S. Marine Corps veteran, attacked Biden for using the armed forces as part of the president's "social experimentation."

"By 2019, the Defense Department announced that it had redirected funds from salaries, equipment and training for 23,992 psychotherapy visits, 9,321 hormone prescriptions, and a whopping 161 surgeries (ranging from hysterectomies and breast augmentation to "male reproductive construction)" Perkins said in a January 25 statement.

While America faces rising threats from around the world, it's obvious that Joe Biden is only interested in using our military to fight one war: The culture war.

America's White Population Shrank for 1st Time in US History, Census Data Show

The 2020 Census results show that the total white population in the United States shrank for the first time in U.S. history, according to data just released by the Census Bureau.

The share of the white population fell to 57.8 percent (191,697,647) in 2020 from 63.7 percent (196,817,552) a decade prior, the data show. Hispanics became the largest racial or ethnic group, growing to 39.4 percent from 37.6 percent over the previous decade, while the white population dipped to 34.7 percent from 40.1 percent.

There were also significant increases among people who identify as multiracial, Hispanic, and Asian, driving much of the population growth throughout the decade. People who identify as multiracial increased by 276 percent, to 33.8 million in 2020 from 9 million in 2010.

The largest gains were among Hispanics, who now make up 18.7 percent of the population, the data show.

Overall, the U.S. population grew by just 7.4 percent during the previous decade, which is the second slowest growth on record, according to the census data. The population grew to 331.4 million in 2020 from roughly 308.7 million in 2010. Only the decade spanning the 1930s—when the Great Depression occurred—had a slower growth rate.

The opioid epidemic and lower birth rates among white millennials accelerated the decline in the white population, the Brookings Institution's William Frey said in a Washington Post interview.

The bureau also noted that as suburbs and cities persistently grew, rural depopulation increased during the decade.

New York remained the largest U.S. city, netting a population gain of 7.7 percent. Among the country's 10 largest cities, Phoenix saw the greatest percentage-point gain—11.2 percent—during the decade.

Overall, the data show that New York, Los Angeles, Chicago, Houston, and Phoenix are the five largest cities in the United States.

Buckeye, a suburb of Phoenix, saw its population increase by nearly 80 percent to lead the nation. And The Villages, a retirement community in Florida, is the fastest-growing metro area in the country, the census data show.

The data, which offer demographic and racial details of every community down to the block level, arrived months later than originally expected after the census took longer to complete due to the COVID-19 pandemic. The delay forced some states to go to court to postpone their redistricting deadlines.

Why is the Census so important? States use the data to redraw district lines for the U.S. House of Representatives after each decennial census, based on where people now reside.

America's Generals Lied, Lost Wars, And Looted the People They Claimed To Serve

Gen. Mark Milley, the chairman of the Joint Chiefs of Staff, told Congress in June that he wanted to understand "white rage," why "thousands of people" tried "to assault this building and ... overturn the Constitution of the United States of America."

If Milley really wants to understand the "rage" of the American people, he should start by asking why he and his fellow generals can't win any wars. As a Marine Corps officer who served at the tail end of the wars in Iraq and Afghanistan, I saw firsthand the rapid ideological transformation pervading the military in the wake of these disasters in the Middle East.

Unable to win wars overseas, the military's leaders went "woke." Currying ideological favor is easier than trying to end insurgencies. It is also necessary if military leaders want to keep the gravy train of taxpayer funding. Donald Trump's America First foreign policy and his devastating critique of George Bush and Barack Obama in the run-up to the 2016 election put the military-industrial complex on high alert. Trump was pushing the American right-wing away from the expensive and unending foreign interventions the military-industrial complex needed in order to justify its existence.

Milley and his fellow generals deserve, richly, to feel the full weight of the American people's anger. For 20 years, these leaders lied consistently to the American people and their political masters about the wars in the Middle East. In December 2019, Craig Whitlock of the Washington Post published a devastating series of articles on America's failure in Afghanistan. Using 600 "lessons learned" interviews with top military staff and diplomatic personnel collected by the Special Inspector General of Afghanistan Reconstruction (SIGAR), Whitlock illustrated just how pervasive the gut rot in America's military really was.

Milley himself claimed, in Kabul in 2013, that "[The Afghan] army and police force have been very, very effective in combat against the insurgents every single day." He was lying.

More than 60,000 Afghan police and military were killed during our occupation compared to just 42,000 alleged Taliban. Afghanistan's military and government were utterly corrupt. American officials, in private admitted that at least 40 percent of the \$103 billion in reconstruction funds spent in Afghanistan went into the hands of insurgents, Taliban, and corrupt "allied" warlords.

If the generals knew this and said nothing to the people, they deserve to be excoriated. If they didn't know, they should have never been placed in positions of responsibility in the first place.

Instead of profiles in courage, America's mili-

tary leaders deserve profiles in grafting. Current Secretary of Defense Lloyd Austin made \$7 million once leaving the service. Gen. James Mattis is reportedly worth \$5 million, including \$150,000 annual payouts from Theranos for serving on their board. Theranos was a blood-testing company indicted for fraud. Not a single senator asked Mattis about the connection at his confirmation hearing as secretary of defense. Gen. David Petraeus, after leaving the CIA in disgrace after revelations of leaking classified information to his mistress and personal biographer Paula Broadwell, went on to a successful career in academia, public speaking, and private equity. His net worth is estimated at \$2 million.

The generals lied, America lost, and the people got looted.

If current congressional leaders won't lead the charge for accountability, then patriots outside the swamp should. Without accountability, a republic falls. America's generals deserve the cleansing fire.

Story of a Civil War

Boy Soldier

In May of 1861 9-year-old John Lincoln "Johnny" Clem ran away from his home in Newark, Ohio, to join the Union Army. But he found out the Army was not interested in signing on a 9-year-old boy when the commander of the 3rd Ohio Regiment told him he "wasn't enlisting infants," and turned him down. Clem tried the 22nd Michigan Regiment next, and its commander told him the same. Determined, Clem tagged after the regiment, acted out the role of a drummer boy, and was allowed to remain. Though still not regularly enrolled, he performed camp duties and received a soldier's pay of \$13 a month, a sum collected and donated by the regiment's officers.

The next April, at Shiloh, Clem's drum was smashed by an artillery round and he became a minor news item as "Johnny Shiloh, The Smallest Drummer."

A year later, at the Battle of Chickamauga, he rode an artillery caisson to the front and wielded a musket trimmed to his size. In one of the Union retreats, a Confederate officer ran after the cannon Clem rode with, and yelled, "Surrender you damned little Yankee!" Johnny shot him dead. This pluck won for Clem national attention and the name "Drummer Boy of Chickamauga."

Clem stayed with the Army through the entire war, served as a courier, and was wounded twice.

Between Shiloh and Chickamauga, he was regularly enrolled in the service, began receiving his own pay, and was soon promoted to the rank of Sergeant. He was only 12 years old.

After the Civil War he tried to enter West Point but was turned down because of his slim education. A personal appeal to President Ulysses S. Grant, by his commanding general at Shiloh, won him a 2nd Lieutenant's appointment in the Regular Army on 18 December 1871, and in 1903 he attained the rank of Colonel and served as Assistant Quartermaster General.

He retired from the Army as a Major General in 1916, having served an astounding 55 years.

General Clem died in San Antonio, Texas on 13 May 1937, exactly 3 months shy of his 86th birthday, and is buried at Arlington National Cemetery.

And to think, today's kids need a safe space to cry in.
