THE SCHOOL-BASED ACCESS PROGRAM (SBAP)

The Pennsylvania School-Based Access Program (SBAP) is a program through the Department of Human Services (DHS) that allows LEAs to receive reimbursement for health-related services provided to MA-enrolled children who are under 21 years of age when those services are documented in the child's IEP.

Public Consulting Group, Inc. (PCG) is the Lot 1 vendor for the Pennsylvania School-Based Access Program. Lot 1 services include operating and maintaining the EasyTrac billing system used to submit claims to DHS for direct services and special transportation.

EasyTrac™ GENERAL INFORMATION

Security

All EasyTrac™ information is confidential. The server uses Secure Socket Layer (SSL) technology to encrypt all information as it flows across the Internet. This is the same technology that online merchants and banks use to protect your credit card number and other sensitive information.

Please adhere to the following procedures to ensure security:

- **Do not give your account name or password to anyone.**
- **Do not write your password down where it can be seen by others.**
- **Do not save documents or reports to an unsecured computer.**
- **Always log off EasyTrac™ and close your browser when you are finished.**

Note: EasyTrac™ will automatically log you out of the system after a period of inactivity.

Navigation

EasyTrac™ is menu bar driven with tabs along the top on the screen that are used to navigate through the system. Clicking different tabs takes the user to different parts of the database.



Saving Changes

After a change is made, it is very important to click the 'Update the Database' button at the bottom of each screen to save the changes. 'Update the Database' is equivalent to **Save**. **Any information entered will be lost if Users forget to click 'Update the Database'.**

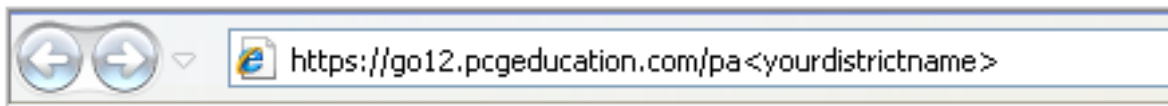

Logging into the System

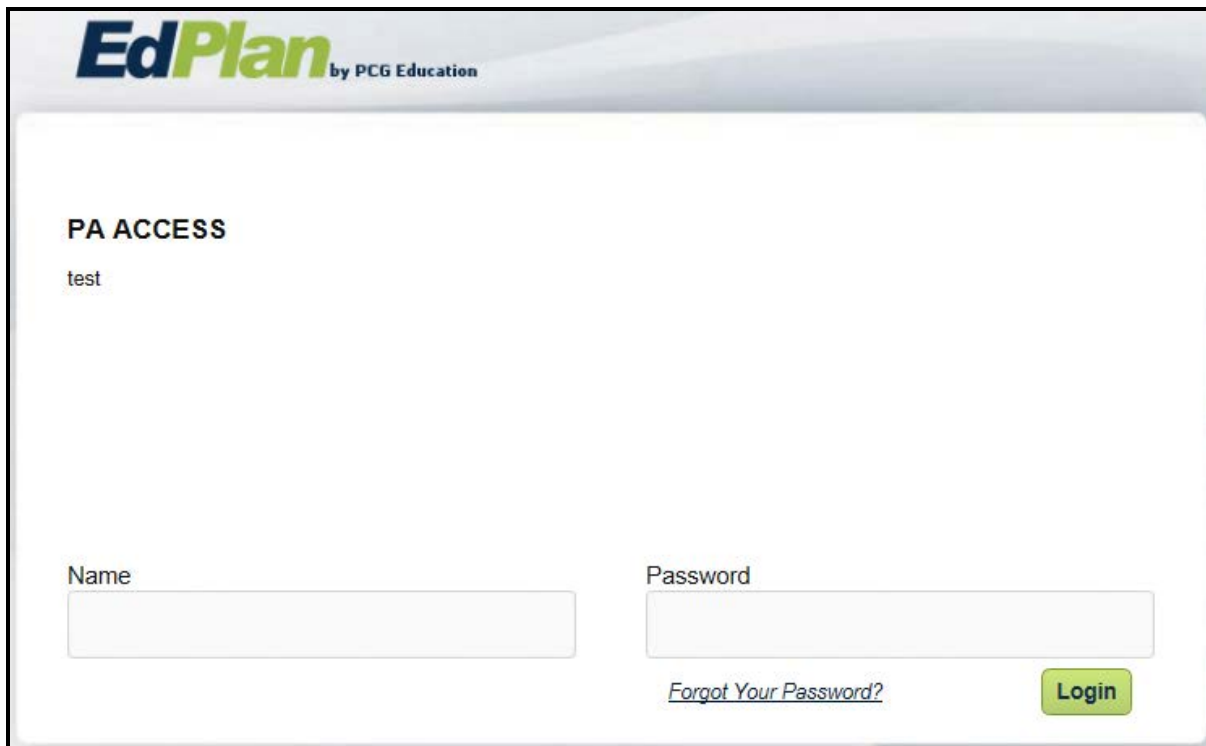
1. Open a web browser and enter your district's URL in the address bar. We recommend that you save this to your favorites or add a short-cut link to your desktop. You will login to the EdPlan™ site; EasyTrac™ is a component of the EdPlan™ system.

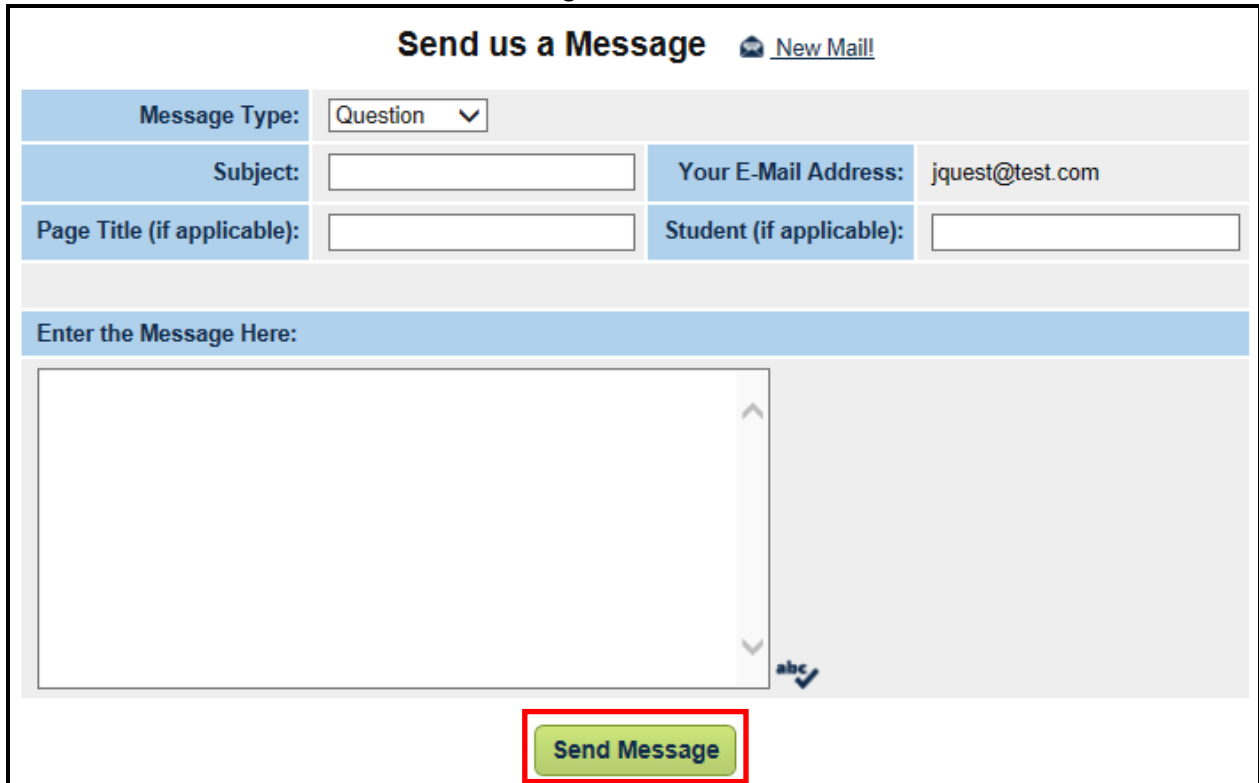

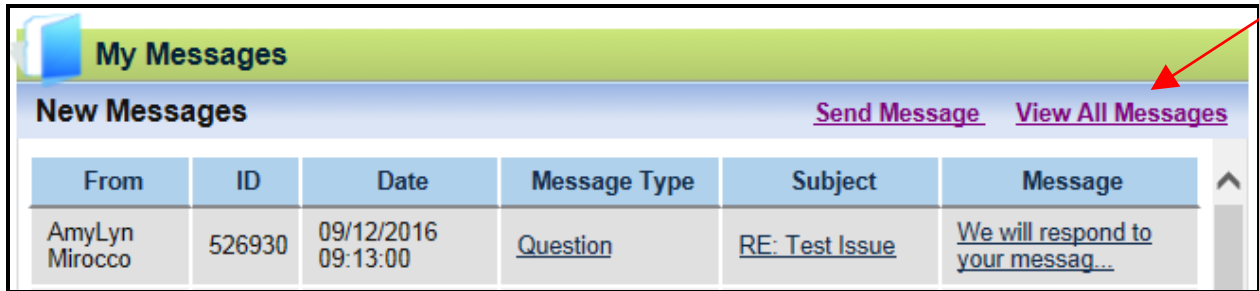
To send a Question, Bug Report, Comment or Suggestion:

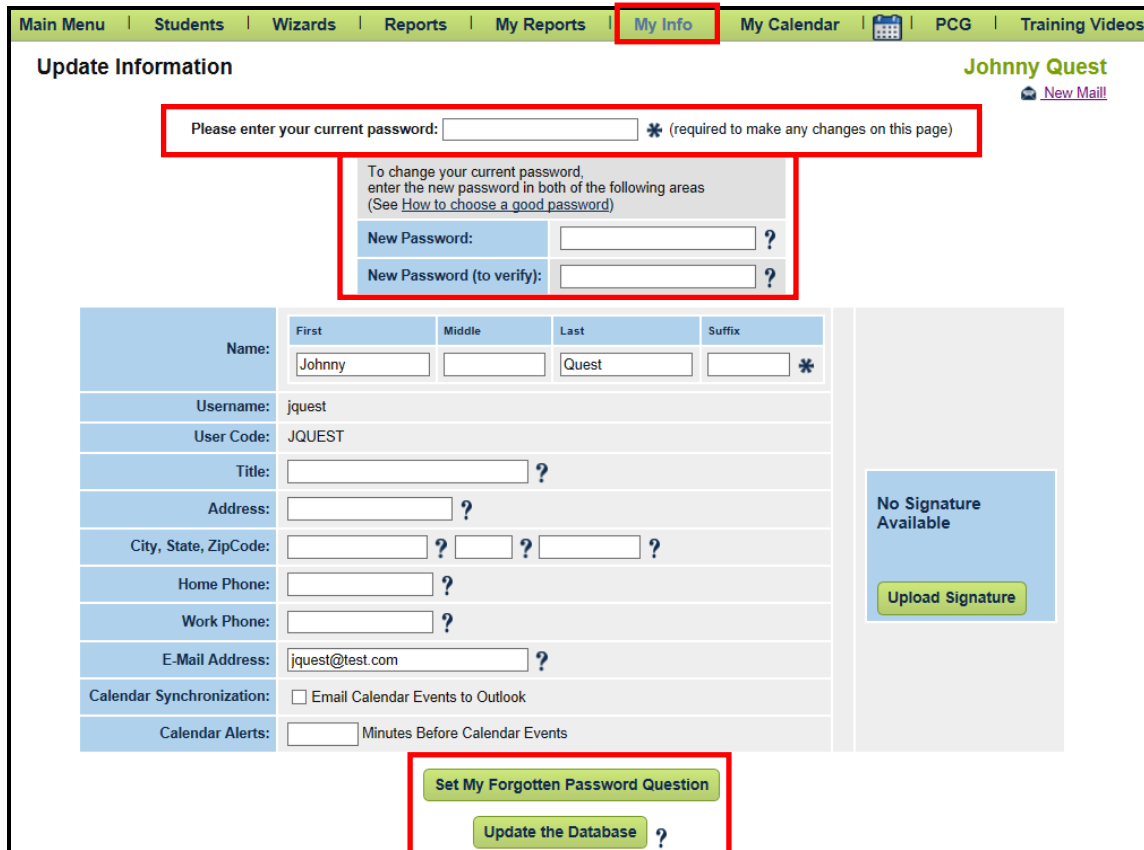
At the bottom of the *Main Menu* page you will see various files that have been made available to you for viewing or downloading. Instead of sending e-mail attachments to everyone in your district, administrators or PCG staff may upload the necessary file to the main page of EasyTrac™. To view a file, click on the name of the file (denoted by a [blue](#) hyperlink). The file will open, and you will have the option of saving it to your computer. When you are finished viewing the file, click on the *Main Menu* tab at the top of your screen. Do not close your browser as you are still logged in to EasyTrac™.

Changing Passwords

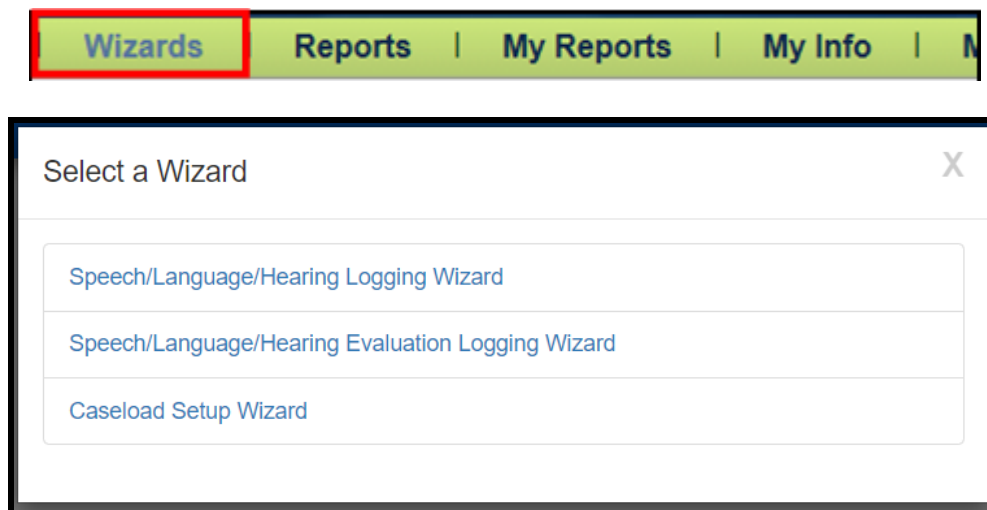
DOCUMENTING SERVICES

Using the Logging Wizard

To begin documenting your services, you will need to have all your students added to your caseload. Once the students are added to your caseload, you will use the Service Logging Wizard for your students. Any changes to a user's caseload must be completed by the districts Access Administrator.

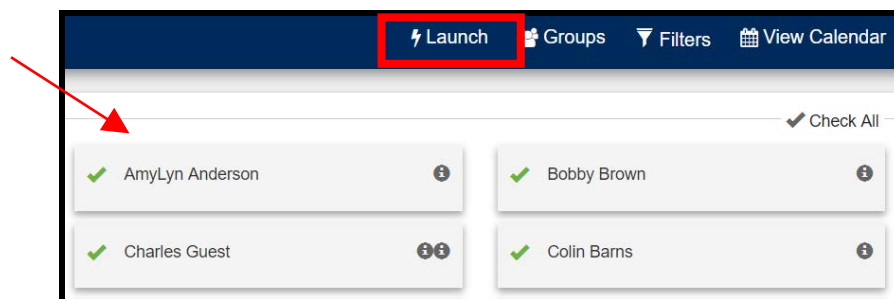
How to Document a Service Log Using the Logging Wizard

1. Login to EasyTRAC™
2. Click on the 'Wizards' tab
3. Click the Logging Wizard for the service that you provide



4. Select the student(s) you wish to document services and click 'Launch.'

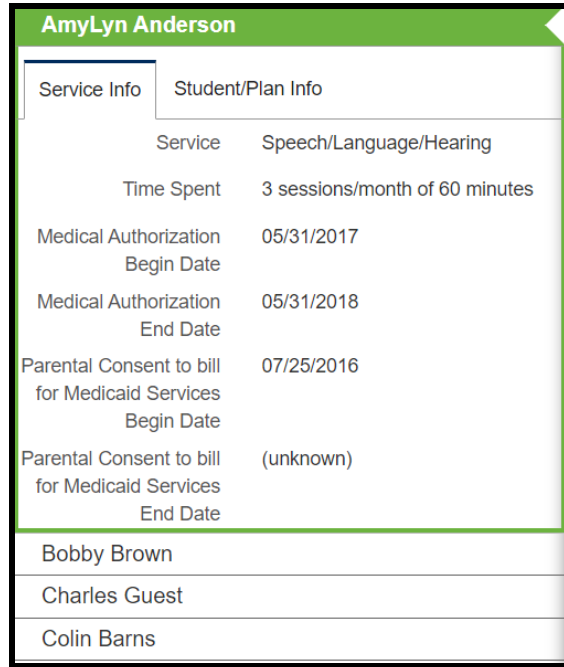
Note: The students listed under **Med: No** are NOT CURRENTLY eligible for MA services. The students listed under **Med: Yes** ARE CURRENTLY eligible for MA services.



Note: If a student already on a user's caseload is not showing up in the logging wizard, the corresponding related service has not been added yet for that student. The ACCESS Administrator will need to add the related service to the students EasyTrac profile.

5. Verify that you are logging a service for the correct student.

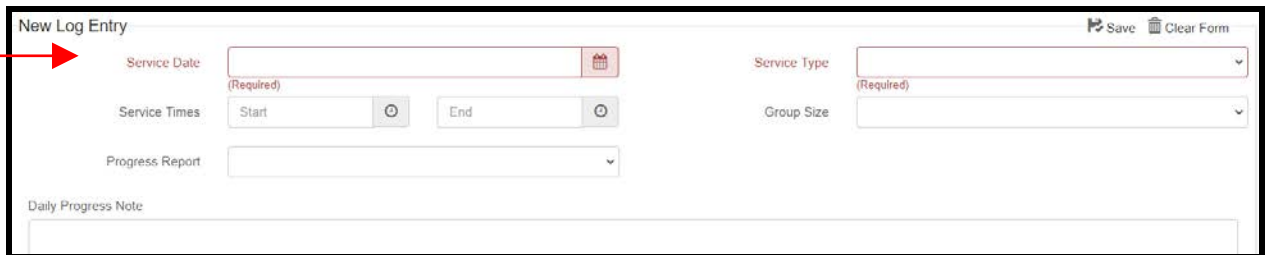

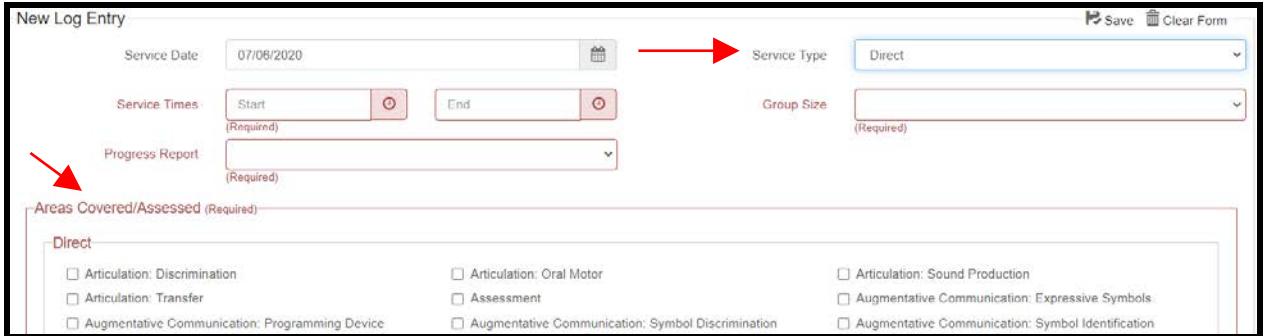

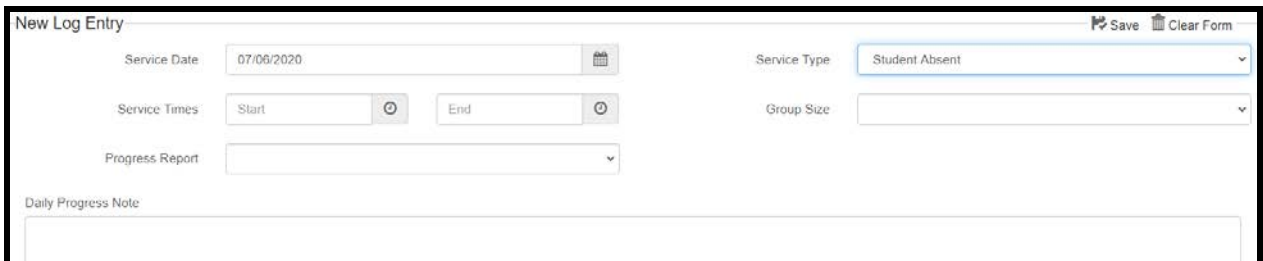

Confirm log(s), then return to the top of the Logging Wizard: Will confirm the entered log and return you to the Wizards tab to select a new Logging Wizard

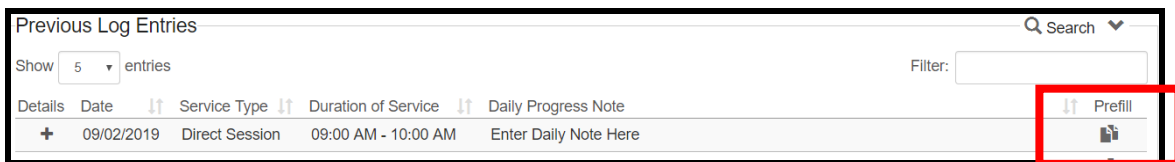
Confirm log(s), then enter more logs for this student: Will confirm the entered log and return you to the logging screen to continue documenting further logs.

Confirm log(s) then return to the Student selection page: Will confirm the entered log and return you to the student selection page under the current Logging Wizard.

How to document a service log using the “Prefill” function

Once a log has been confirmed via steps 1-8 in the previous section, the log will appear at the top of the screen with a ‘Prefill’ icon available. To use the prefill button for further log entry:

1. Select the icon under the “Prefill” column next to the log you want to fill in the data from.



2. The new service log will be populated based off the data from the log selected.

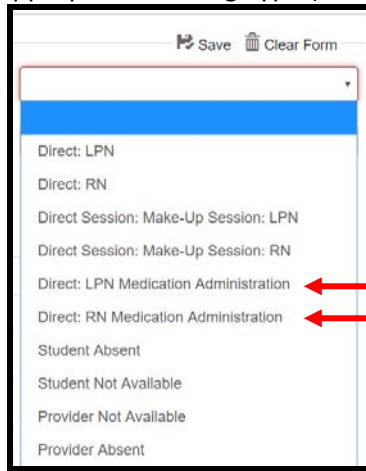
Note: The specific fields that will prefill are:

- Service Type
- Service Times
- Group Size
- Areas Covered/Assessed

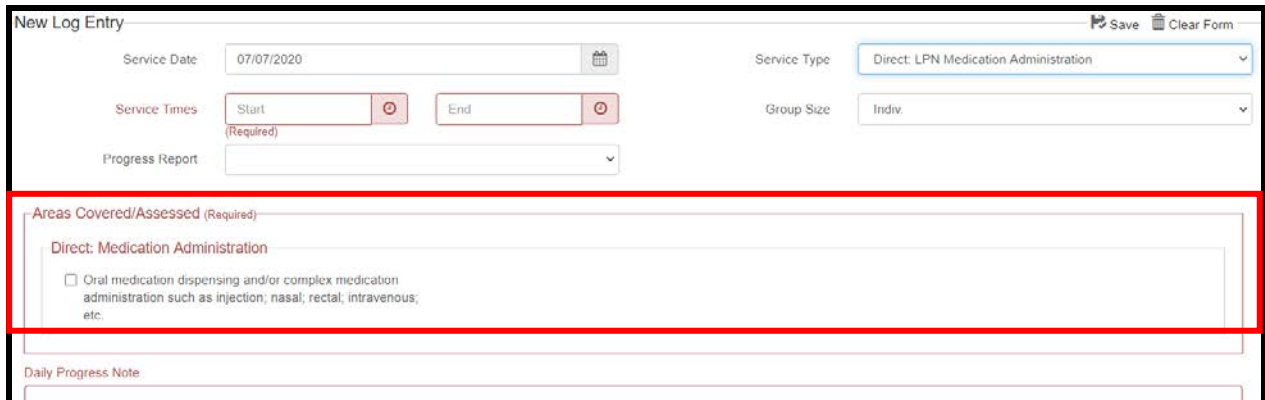
The remaining fields are required to be entered manually with the completion of each service log. Logs must contain documentation showing the differences and needs of the student for each encounter.

Documenting Nursing Medication Administration Services

1. Click on the “Wizards” tab on the top of your Internet window
2. Click the “Nursing Logging Wizard”
3. Check the boxes for the student for whom you wish to document services, then click “Launch”
4. To log for Medication Administration, you will select the “Medication Administration” service type for the appropriate Nursing Type (RN or LPN).



5. Complete all required information for the log.
6. By selecting the “Medication Administration” Service Type option (LPN or RN), only the Medication Administration Areas Covered/Assessed is able to be selected.



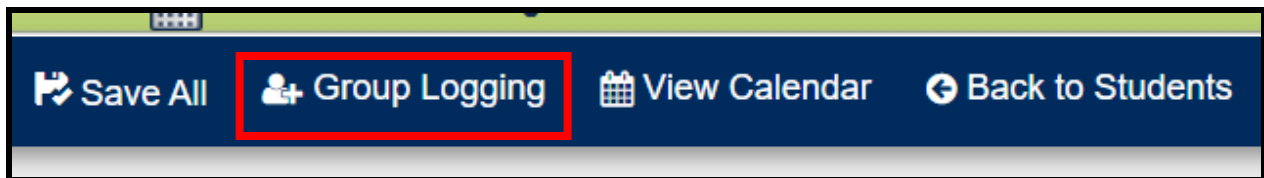
Note: A selection of the “Direct: Medication Administration” Areas Covered/Assessed CANNOT be combined with any other Areas Covered/Assessed. All Medication Administration logs must be logged separately from Direct Nursing Service logs.

Documenting Group Services

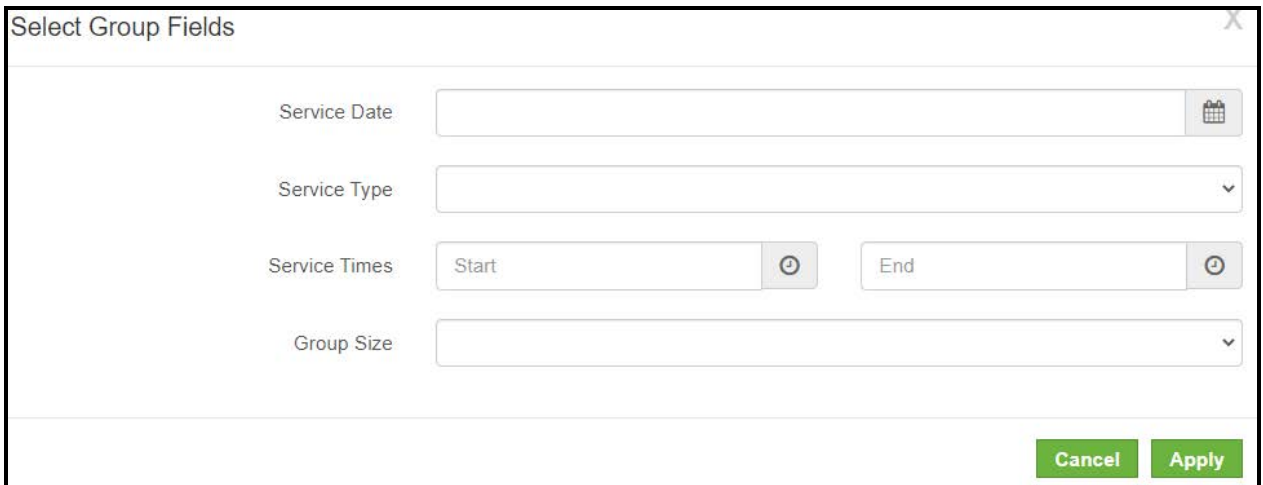
1. Click on the “Wizards” tab on the top of your Internet window
2. Click the Logging Wizard for the service that you provide
3. Check the boxes for the students for whom you wish to document services, then click ‘Launch’

Note: You should only check off students that were in the same group session, on the same day, at the same time. Service provided to one student only cannot be documented as a Group Service in EasyTrac.

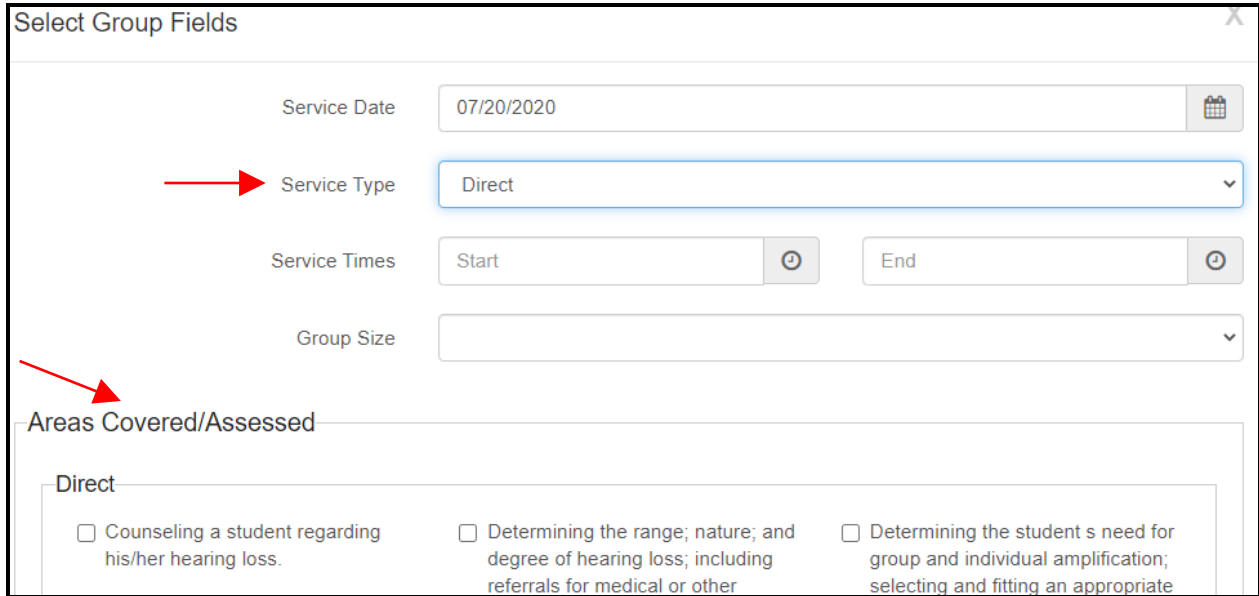
4. Once in the Wizard, select “Group Logging” from the top right side of the page



5. Complete the data fields that apply to the entire group for the service you provided, then click ‘Apply’ to add the data that applies to each specific student

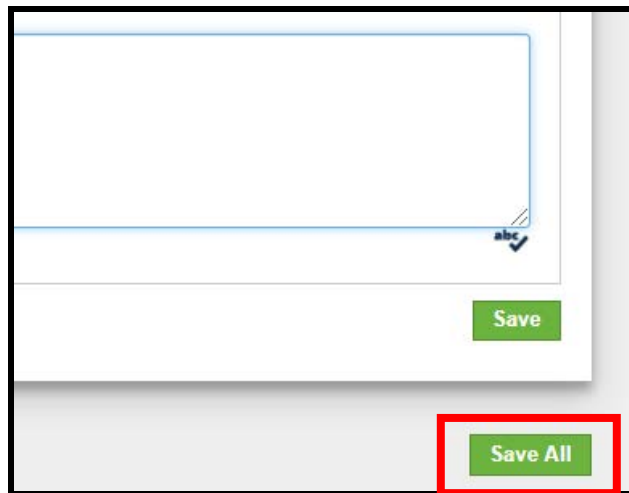

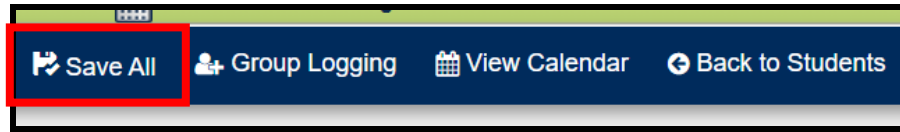
7. The Service Date, Service Type, Service Times, Group Size, and Areas Covered/Assessed will carry over from the first page into the Student Specific pages. On the Student Specific Information page, further information can be added or changed to reflect the session for that student including Progress Report, Daily Progress Note, and further Areas Covered/Assessed.
8. Review the services for each student. When finished, select “Save All” at the bottom of the page.

9. If changes need to be made to entries, select “Edit” on the confirmation screen to return to the previous page. Otherwise, select “Delete” to start from the beginning, or “Confirm log(s), then return to the top of the logging wizard” or “Confirm log(s), then return to the Student selection page” to complete and save the log for each student.

Electronic Signatures

Electronic signatures for completed logs are accepted effective 7/1/2012 for all services rendered after 7/1/2012.

DPW will accept SBAP provider logs that are signed with an electronic signature provided the electronic signature meets the following requirements:

- Identifies the individual signing the document by his/her name and title;
- Ensures that the document cannot be altered after the signature has been affixed by limiting access to the code or key sequence;
- Provides an audit trail that validates the signer's identity.

Upon request from DPW, schools must be able to provide a hard copy of the log showing either verification of the provider's PIN/password or an actual signature. A handwritten original is not required.

Schools that use electronic signatures must have written policies and procedures in effect regarding use of electronic signatures. Electronically transmitted signatures must be electronically encrypted or transmitted by other technological means designed to protect and prevent access, alteration, manipulation or use by any unauthorized person. In addition to complying with security policies and procedures, providers who use computer keys or electronic signatures should sign a statement assuring that they alone will have access to and use the key or computer password. The policies, procedures, and statements of exclusive use must be maintained and available at the school's location.

Paper Logs

Effective July 1, 2012, providers who bill ACCESS will no longer be permitted to submit paper claims.

Paper logs that match the EasyTRAC™ logging wizards have been created for end users if requested. Each item on the paper log is mandatory. While paper logs can be completed by an end user, all finalized logs must be entered in EasyTRAC™ by that end user or the Access Coordinator/Supervisor.

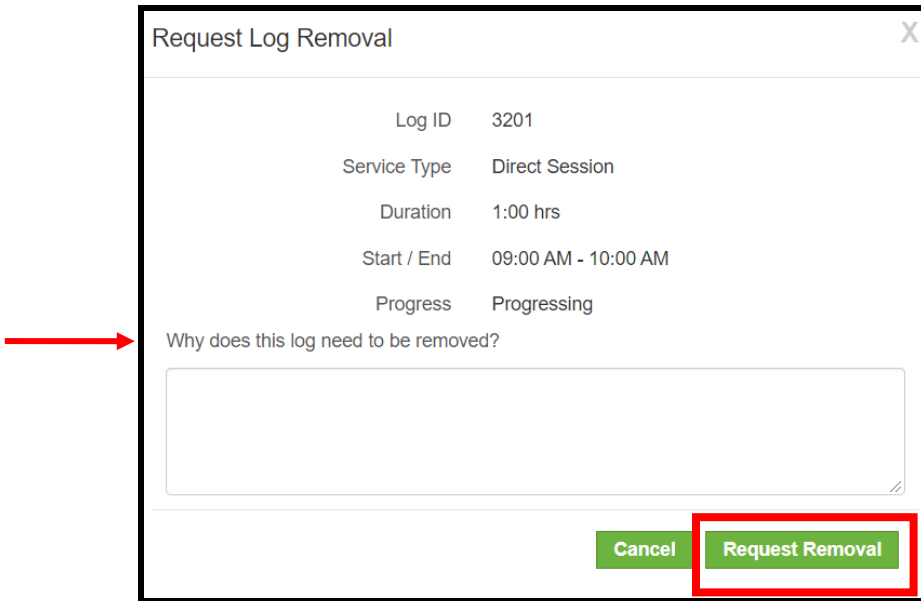

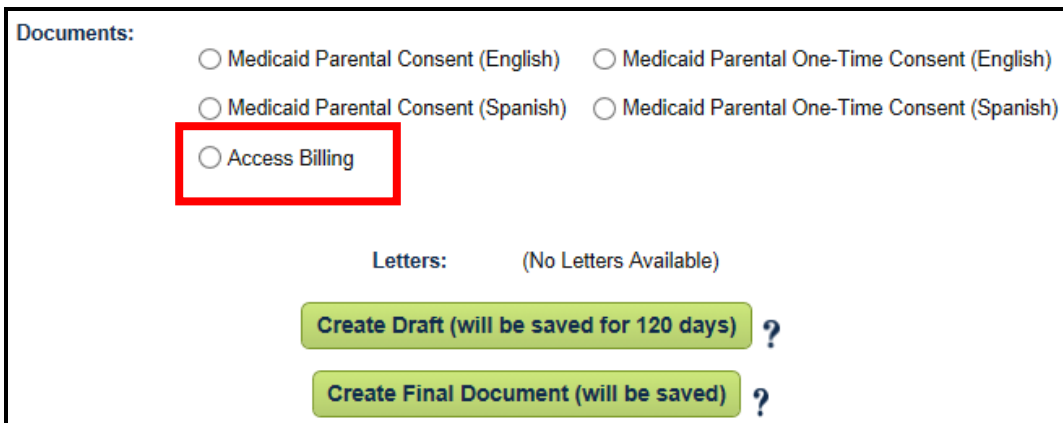

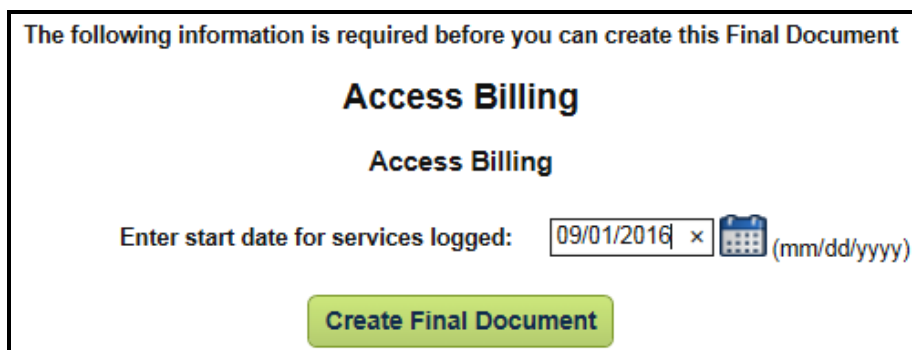

5. Click the radio button to the left of **Access Billing**



6. Select "Create Draft" or "Create Final Document"
7. Identify the start date for the month of service logs to be printed. The document will print the full month.
