



Privacy Policy

Commitment to Privacy

Safe Expo, LLC has adopted a policy that protects the privacy and confidentiality of protected health information (PHI) whenever it is used by company representatives. The private and confidential use of such information will be the responsibility of all individuals with job duties requiring access to PHI in the course of their jobs.

What is Personal Health Information

Personal Health Information refers to individually identifiable health information that relates to the past or present health of the individual. PHI includes medical conditions, health status, claims experience, medical histories, physical examinations, genetic information and evidence of disabilities.

Principles of Privacy

Our Privacy Policy reflects our compliance with fair information practices, applicable laws and standards or practice. *This policy was last modified July 1, 2025.*

Accountability

We take our commitment to securing PHI seriously. Each provider and employee with Safe Expo is responsible for the PHI under his/her control. Our employees are informed and educated of the importance of privacy. They receive information and training periodically to update them about our privacy policy and related issues.

Identifying Purposes: Why We Collect Information

We ask you for information to determine eligibility, where local and state laws permit, of participation in our clients events. We obtain our information about you, directly from you, or from health practitioners who you have seen and authorized to disclose to us. We limit the information we collect to what we need for these purposes and we will only use it for these purposes. We will obtain your consent if we need to use your information for any other purposes.

Consent

You have the right to determine how your personal health information is used and disclosed. By reading this Privacy Policy you understand failure to disclose required PHI, where local and state law permit, may result in your limitation and/or failure to attend events by the hosting party.

Limiting Collection

We collect information by fair and lawful means and collect only information which may be necessary for purposes related to determining eligibility of participation.

Limiting Use, Disclosure and Retention

The information we request from you is used for the purposes defined. We will seek your consent before using your information beyond the scope of this Privacy Policy.

Under no circumstances do we sell personal information to third parties. Information may be disclosed for business services or support and does so with the understanding that they abide by our Privacy Policy. Any disclosure of information will only be done after expressed written consent from you.

We will retain your information only for the time it is required for the purposes we describe and once it is no longer required, it will be destroyed.

Accuracy

We endeavour to ensure that all decisions involving your personal information are based upon accurate and timely information. While we do our base to base our decisions on accurate information, we rely on to disclose all material information and to inform us of any relevant changes.

Safeguards: Protecting Your Information

We protect your information with appropriate safeguards and security measures. Safe Expo, LLC maintains personal information in a combination of electronic and paper files, depending. Recent paper files containing personal information may be kept onsite, while older files are stored securely offsite.

Our computer systems are password-secured and constructed in such a way only authorized individuals can access secure systems and databases.

Access to personal information will be authorized only for Safe Expo, LLC employees and those otherwise authorized by law.

Openness

Safe Expo, LLC has prepared this plain language Privacy Policy to keep you informed. You may receive a copy upon request.

If you have any additional questions or concerns about privacy, we invite you to contact us and we will address your concern to the best of our ability.

Access and Correction

With limited exceptions, we will give you access to the information we retain about you in a timely manner, upon presentation of written request and satisfactory identification.

We reserve the right to refuse any misleading or unsatisfactory submissions. We are not required to correct information made in clinical observations or opinions made in good faith.

If we deny your request, we will advise you in writing of the reason for refusal and you may then challenge our decision.
