The undersigned, being the legal parent(s) or guardian(s) of _____ a minor child (hereinafter referred to as the "MINOR"), being of legal age and residents of the State of Mississippi, do hereby consent and grant to Mississippi Authority for Educational Television, d/b/a Mississippi Public Broadcasting (hereinafter "MPB"), permission to:

1. Post and to make, have made, use, copy, reproduce, modify, publicly display, import, broadcast, transmit, and otherwise distribute (directly or indirectly), in any media now known or hereinafter created, photographs, film and record the voice of Minor in connection with the Production listed above. This irrevocable, royalty-free, and unconditional limited license is granted worldwide in perpetuity;
2. Permanent permission to use and edit the recording including the Minor's name, voice and likeness, in all media, now known or hereinafter created, MPB may use to distribute its programs worldwide, including promotional use, and I release MPB and its licensees from any claims or actions arising out of the use of the Recording;
3. To put the finished pictures, negatives, reproductions and copies of the original prints and negatives of the Minor and any sound track recordings, and recordings which may be made of the Minor's voice, including the right to substitute the voice of other persons for the Minor's voice, the Minor's name, or likeness, (collectively "Tangible and Intangible Items"), in said Production; and
4. To use said Tangible and Intangible Items in any manner deemed proper by MPB so long as such use is in connection with the exhibition, promotion of MPB, distribution and/or exploitation of said Production

The undersigned further agrees and warrants that the above-mentioned Minor, will not disaffirm or disavow this consent and permission on the ground that the Minor was a minor on the date of execution thereof or any similar grounds whatsoever, or endeavor to recover from MPB or any of its individual shareholders, directors, officers, employees or other associated persons, or through any guardian, any sums of participating in the Production. I understand that neither the Minor nor I will receive compensation from MPB, financial or otherwise, regardless of how or where any completed versions of the Production might be distributed.

I agree that MPB owns all rights and proceeds of Minor's services rendered in connection herewith as a work made for hire. Should contribution be determined to not be a work made for hire, I hereby assign, transfer and convey to MPB, for no additional consideration, all rights in the performance, worldwide and in perpetuity.

Should contribution be determined to not be a work made for hire, I hereby assign, transfer and convey all rights to MPB, for no additional consideration, exclusively, worldwide and in perpetuity.

MPB shall not be obligated to use talent's services, and shall not be liable to talent in any way for failure to do so in whole or in part.

This Agreement has been entered into in the state of Mississippi, and its validity, constructions, interpretation and legal effect shall be governed by the laws of the state of Mississippi applicable to agreements entered into and performed entirely within the state of Mississippi. I hereby certify and warrant that I am over the age of eighteen (18) years, have full power, right and authority to enter into this consent and release, have read same in its entirety and understand all of its terms and provisions.
