RULES & GUIDELINES



RULES

- All members must agree to and adhere to all WTT club rules.
- A Player Profile must be completed if WTT doesn't not have one on file.
- All matches must be played at WTT Allentown to count as an official league match.
- Players are responsible for contacting opponents and setting up matches with consideration of the availability of all players. Sue Pettit, League Coordinator, will email a league roster/directory with player contact information to all registered players within a division.
- WTT uses an honor system that players/teams, in good faith, will schedule and play as many matches as possible.
- The 2-day (guests)/5-day (TAP) reservation applies.
- League matches are reserved for 2 hours and **DO NOT COUNT** as your daily play if you are a WTT TAP member.
- Players/teams decide who provides the balls. If a mutual decision cannot be reached, hard court balls can be purchased at the desk for \$6.00 and the cost split by all players.

FEES

- League fees must be paid when registering for the league.
- WTT Allentown TAP players pay a one-time \$10 fee for each league division playing.
- WTT Allentown guest players pay a one-time \$25 fee for each league division playing.
- Court fee for WTT Allentown guest players is: \$25 for doubles and \$40 for singles.

FORMAT

- A match will be the best two out of three sets. A 10-point super tiebreaker will be played in lieu of a third set (first to 10 by 2). AD scoring.

-At the completion of the match, the winning team emails the score to WTT at wtallentown@gmail.com and includes the specific league, all player names, winner names and score in terms of the winner or calls in the score to the WTT desk associate who will record them in the computer for USTA to enter in Tennis Link. Standings can be found on the WTT website.

CHAMPIONSHIPS

-At the end of the league, the top 2 teams/individuals play for the league championship. If a league has brackets, the top 2 teams/individuals in each bracket will advance to a playoff.

WTT uses the USTA Tennis Link database to calculate standings.

-If players/teams have the same win-loss record, league winners will be determined, in the order listed, using the following:

- Head-to-Head
- Individual Matches Won
- Least Sets Lost
- Least Games Lost

-If a player/team does not play at least 50% of the matches in their flight, the scores will be removed from the final standings.

MISCELLANEOUS

-If a player gets injured, it is their responsibility to notify their opponent(s) that they are injured and reschedule their matches when able. If the injured player is unable to play their remaining matches, please notify Chris Hudak. Subs are not permitted unless approved by Chris Hudak.
