Discussion Topic: Re-opening in Phase I

Opening plan thoughts:

- If the weather permits hold outdoors with lawn chairs or in cars
- No Sunday school or nursery to begin (parents attend children)
- Multiple services of 50 or less when that phase is reached
 - Allow at risk persons to attend first
- Children's story during Worship
 - Stay in pew
 - Mark six-foot distance for each child to stay on mark
- Cleaning of church
 - Clean and sanitize between each service (pews, chairs, handles, doors)
 - Remove all cushions
 - Remove hymnals and Bibles
 - Antibacterial pledge
