

Families must have a home in order to engage in treatment, employment, education and other activities so that they can achieve stable recovery to care for themselves and their families. Attendees will learn how various communities are forging essential partnerships to meet this critical need.

WHY QUALITY LEGAL REPRESENTATION MATTERS FOR PARENTS IN FAMILY TREATMENT COURTS

TEENS MATTER - MEETING THE UNIQUE NEEDS OF ADOLESCENT YOUTH

This Conversation will highlight the importance of serving adolescent youth in your FTC. Their unique development needs, brain function, and social connections require an approach that emphasizes youth engagement and meaningful relationships with peers and adults. Special emphasis will focus on building a strong voice and promoting active participation in planning their own lives to ensure that they will be equipped to successfully transition into adulthood. Key principles and strategies for prevention, quality substance use disorder treatment for adolescents, and recovery support will also be highlighted.
