

Process to request a NC Wesleyan North Carolina license plate
ORDERS MUST BE RECEIVED BY JANUARY 15, 2019



DESIGN UNDER REVIEW. DRAFT PLATES SUBJECT TO DMV APPROVAL

1. Completely fill out the included MVR-27PP-A form (one form per plate request).
2. Draft a check or money order to NCWC (North Carolina Wesleyan College) in the amount of either:
 - a. \$25.00 for each First in Flight or Freedom tag with the Wesleyan logo on the left side.
 - b. \$55.00 for each First in Flight or Freedom tag with the Wesleyan logo on the left side and for four (4) customized letters or numbers. Customized letter/number plates will be processed in the order received. Consecutive numbers are not allowed. Please include a 2nd option.

NOTES:

Applicants must submit a complete MVR-27PP-A form per each plate request but can provide a single payment per applicant.

Upon receipt of 300+ paid orders, NC Wesleyan College will forward all MVR-27PP-A forms to the North Carolina Department of Motor Vehicles with a consolidated check totaling all collected fees.

NC Wesleyan College will notify applicants if 300+ paid orders are NOT received and will return or destroy the payments to all applicants according to each applicant's guidance.

If approved, the NCDMV will issue the plate within 180 days after receipt of the requester's design and the minimum number of paid applications.

Application Process:

- 1. FORM MVR-27PP-A MUST BE SUBMITTED TO THE ORGANIZATION PRIOR TO FEBRUARY 15 OF THE CURRENT LEGISLATIVE YEAR. THIS SHOULD INCLUDE THE ADDITIONAL PROPOSED FEE FOR THE PLATE TO BE CONSIDERED FOR LEGISLATIVE APPROVAL.
2. IF THE PLATE IS NOT AUTHORIZED BY LEGISLATION, DMV WILL REFUND THE FEES COLLECTED TO THE ORGANIZATION.

PLEASE REMIT THE SPECIAL FEE MADE PAYABLE TO THE ORGANIZATION IN THE FORM OF CHECK OR MONEY ORDER WITH THIS APPLICATION. IF YOU CHOOSE TO REQUEST A PERSONALIZED PLATE TEXT, THERE IS AN ADDITIONAL \$30.00 FEE.

ANY REFUND REQUESTS MADE BY POTENTIAL PURCHASERS IS THE RESPONSIBILITY OF THE PERSON, ORGANIZATION, OR LEGAL ENTITY SEEKING THE PLATE, NOT THE NCDMV.
