### Schottenfreude – Shameful Joy

The first time I heard this word was when I was listening to a CD by Bishop Robert Baron. It was entitled Seven Deadly Sins; Seven Lively Virtues. You experience schottenfreude when you feel pleasure derived from the misfortune of others. I highly recommend listening to this talk as it goes a little deeper into the Deadly Sins. So that got me thinking about our words and how we use them.

Sticks and stones may break my bones, but words will never hurt me. What a joke! Words can leave a more lasting scar than any broken bones or stitches. Words can hurt us inside where the wounds are harder to heal. There are no band aids that can stop the hurt of words said in frustration or anger. No matter how many times we say we are sorry or wish we could take it back, the damage is done.

Friendships, relationships, and our own self-worth can be damaged when we use words to get back at someone who has hurt us. Negative talk – telling ourselves that we are no good, degrading or demeaning another or spreading false rumors can be devastating.

And when we are in that state of lashing out, aren't we sometimes secretly glad that the other person has been bested by us? Schottenfreude.


Then comes that time we are sorry we hurt them, but how can we un-say the words and undo the damage we have done? When we sin, we hurt the other person, God and ourselves. Mending these hurts will take some work on our part.

We need to not only say we are sorry, but really mean it. The words, "I'm sorry" come too easily nowadays. It is the standard apology – one size fits all. It covers circumstances, but little thought goes into saying the words. They are just the expected response. But it is a start to rebuilding that relationship.

Now it is time to take a serious look into our heart. Repentance is sincere remorse about the wrongdoing, the hurtful words and results - the sin. It is a deep regret. It is "I'm Sorry" on steroids. This begins the healing of ourselves.

Another step involves asking for forgiveness from those we have hurt. We need to be sincere in our asking. That person needs to know and feel our sorrow and regret. We admit our guilt and begin to mend the relationship. When **they** forgive **us**, they will begin to heal.






This season I was going to try fasting. Which is more difficult?



We have many women in our church council who can step into the leadership roles. What are the reasons why there are no women at the council meetings or in the roles?

Time or lack of: Is your meeting suitable for the younger moms? Are they suitable for the older moms? Have a program, then a short business meeting. Zoom allows more flexibility for programs from outside your deanery.

Work: An 8 hour day is not a time when a professional woman wants to leave and go to a meeting. Can you change your meeting time that works for some women?

School: Activities pull even the grandparents away. It is important to be flexible in scheduling your meetings. Maybe have your meetings on a Sunday afternoon or during CCD? Provide a comforting respite for the moms waiting for their kids. .

Kids and Family: No doubt these things come first! But you as a Catholic woman needs to tend to your soul. Bring a friend to the meetings, make sure they are enjoyable.



SWOT Analysis: Spend some time during the summer when the above issues are not a problem with meetings. Invite the ladies in for a time of fellowship. Go visit a museum, attend a movie and participate in a sip and paint exercise. Then go back to the hall and ask what are the

- 1. Strengths-How is your community?
- 2. Weaknesses Do you have volunteers?
- 3. Opportunities— What can you do to grow your community?
- 4. Threats—What takes from your church? Social media, activities.

From the Nebraska Catholic Conference: Everyone has a role in the fight for life. Here's how you can stand with us:

Look out for future Calls to Action--this is just the beginning of a long road for these bills!

Go to www.necatholic.org and sign up for updates so you can be aware of calls to action, etc.

#### Nebraska Legislative Bill Watch:

LB 715 by Senator Megan Hunt - Expand Abortion Health Insurance Coverage. Hearing will be held on March 1, 2022. Repeals current prohibitions on abortion coverage in public health insurance programs.

LB 716 by Senator Megan Hunt - Expand Eligible Abortion Providers. Hearing was held on February 24, 2022. Permits advance practice registered nurses, certified nurse midwives, and physician assistants to perform abortions.

LB 741 by Senator Wendy DeBoer - Review and Protection of Stillbirths. Placed on General File on February 1, 2022. Provides an additional responsibility for the State Child and Maternal Death Review Team to identify and understand the causes and incidences of stillbirths and provide recommendations for preventing stillbirths.

LB 781 by Senator Julie Slama - Heartbeat Act. Hearing was held on February 24, 2022. Requires an ultrasound to be performed prior to any abortion, in order to detect a heartbeat which if detected would make it illegal to perform an abortion.

LB 774 by Senator Tom Brewer - First Freedom Act - restores religious freedom protections by ensuring that laws that burden religious practice are subject to the compelling interest test, which requires the government to show that its interest in burdening was compelling and that it was doing so in a narrowly tailored fashion. Hearing held on January 19, 2022.

LB 929 by Senator Anna Wishart - Extended Medicaid for Postpartum Mothers. Extends the amount of time for postpartum mothers who have Medicaid coverage, from 60 days to 12 months. Hearing held on January 26, 2022.

LB 933 by Senator Joni Albrecht - Human Life Protection Act. Protects the life of preborn children from the moment of conception, if Roe v. Wade is overturned. Hearing held on February 24, 2022.

LB 1086 by Senator Suzanne Geist - Chemical Abortion Safety Protocol. Provides for evidence-based protections to safeguard women's health by requiring abortionists to screen women for risk factors before prescribing abortion-inducing drugs, prohibiting the prescription of these drugs after 7 weeks gestation, requiring follow-up visits and the reporting of any complications, and halting abortion drugs by mail from out-of-state practitioners. Hearing held on February 24, 2022.

LB 1129 by Senator Adam Morfeld - Free Taxpayer Funded Contraception. Requires the state to provide free contraception to any woman requesting contraception. Hearing held on February 24, 2022.

LB 1213 by Senator Joni Albrecht - Database Provider Obscenity Liability. Description: Requires educational database providers contracted to provide digital and online resources to K-12 students to filter out obscene and harmful materials, and allows for parents to pursue legal action against the database provider where a violation has occurred. Hearing held on February 9, 2022.

Sign up for these sessions through NCCW website to let your voice be heard. These thoughts and ideas about the future of our Church will be taken back to the USCCB and to the Pope's Synod in Rome.

Remember to join in on the Rosary Calls and meditations on the 13th of every month. Also, the Member Calls on the third Thursday of each month. They are enriching and informative.

If you are participating in any "neat" service works or activities remember to take pictures and submit them to NCCW. They will post them in the News section on the website.

To be eligible to vote for NCCW officers and receive the Catholic Woman magazine and keep up to date on council activities, you need to be a member of NCCW. Individual membership is \$50. Voting for national treasurer begins April 1st. When you join as a new member, please write Province of Omaha or my name on the form so that the province will get credit as part of the funds that we are expected to raise each year. The Decade Club replaces the Birthday Club which asks for a commitment of \$100 a year for ten years.

Registration for Catholics at the Capitol is open. CAC is March 9 beginning with coffee and rolls at St. Mary's Catholic Church in Lincoln. Add to the agenda after the closing at 2:00 to travel to Planned Parenthood to pray the Rosary. The executive board meeting is the evening before on March 8, at 7:00 at St. Michael's Church, 9101 South 78th Street. All are welcome.

For the National Council of Catholic Women Convention in 2025, letters of invitation from Archbishop Lucas and the president of OACCW have been submitted to NCCW. We are waiting to hear what the next process will be. Remember this year's convention in Minneapolis, MN, November 2-5.

# Proposed Amendment to the LDCCW Bylaws Adopted 2004, Revised 2016



# This amendment will be put to a vote of the Full Board at the 63<sup>rd</sup> Biennial Convention on April 23, 2022 in Holdrege, NE.

Article 5: LDCCW Nominating Committee, Section 2:Nominations, B: Eligibility, Subsections: i and ii.

Current Bylaws read:

Nominee for President-elect shall be a member of the current and/or past LDCCW Executive Board. Nominees shall have exhibited leadership in the Parish, Deanery, Diocese and Community.

All nominees shall exhibit leadership qualities related to specific offices.

Proposed Amendment change shall read as follows:
All nominees shall exhibit leadership qualities related to specific offices.

The proposed amendment eliminates the requirement of past membership on the Executive Board. This allows more members the opportunity to seek the office of President-Elect.

The process to amend the Bylaws began at the 2020 LDCCW Fall meeting with the President appointing a Bylaw Committee. Over the past year, at each LDCCW meeting of both the Executive board and the Full Board, the committee proposed various options to the amendment. At the 2021 Fall LDCCW meeting of both the Executive and Full Board, the final wording of the amendment was accepted, but not adopted.

The amendment to the Bylaws shall be presented for adoption at the 2022 LDCCW Biennial Convention on April 23, 2022. A vote of approval by two-thirds of the delegates present is required for the amendment to be adopted.
