## NCNC 2022 Water Training Workshop

There is a hint of spring in the air and that means Newfoundland water training is just around the corner. The annual NCNC water training workshop starts off the season. This year's workshop will be presented by Kathy Mitchell (please see the included bio) and it will have two sessions.

Session #1 will introduce theory and methods with a special focus on the critical "Take - Hold - Give" skill. It is scheduled to give participants time to work on and solidify the introduced skills prior to going to the water in Session #2. It will be a land only session to be held tentatively at Northwest Park in Dixon, CA on Saturday, April 9 beginning at 9:00am. It is highly recommended that you attend in person but the this session will also be available on Zoom (hopefully!).

Session #2 will be held at Folsom Lake on Saturday, June 4 and Sunday, June 5. This session will give participants the opportunity to get into the water with their dogs and try out their newly acquired skills and training methods with Kathy assisted by experienced NCNC trainers.

The fee for the workshops is \$40 with a dog and \$20 to audit (participation without a dog). All well behaved dogs and their people are welcome.
