Individual Tax Credits

- Individuals can redirect their Pennsylvania state tax dollars to support education.
- Individuals are eligible to receive up to a 90% tax credit when they participate.
- Designate those tax dollars to support Independence Mission Schools' new model of urban Catholic education.

Corporate or Business Tax Credits

- Businesses can redirect their Pennsylvania state tax dollars to support education.
- Businesses are eligible to receive up to a 90% tax credit when they participate.
- Designate those tax dollars to support Independence Mission Schools' new model of urban Catholic education.


It starts with you when you decide you want to participate.

Tax Credit Program for Individuals and Corporations

The Tax Credit Program is a unique way for individuals and corporations or small businesses to support Independence Mission Schools and one of the fifteen schools in our system.

TAX CREDIT AND HOW IT WORKS:

- For a two-year commitment, individuals or businesses receive a tax credit of 90% of their contributions and a Federal tax deduction for the remaining 10%.
- For a one-year commitment, individuals or businesses receive a tax credit of 75% of their contribution and a Federal tax deduction for the remaining 25%.

THE PROCESS AND WHAT TO EXPECT:

- The process is fairly simple for all involved. Once an individual or business decides that they would like to participate, we connect them with Nick Voight.
- Nick will meet with them to explain the program and what to expect.

We are here to make it as simple as possible for the Donor. Once an amount is determined, we will begin the simple, but effective, process to finalize.
