Message from the Mayor . . .

Dear Fair Haven Residents:



The Borough has strived to address all your concerns during the ongoing coronavirus pandemic. We have done so by trying hard to balance public safety with personal freedom, particularly when it comes to leaving our parks open to the public. I recently received a letter from a resident who strongly objected to our decision to keep our local Fair Haven parks open to the public. I am sharing my response to this complaint, so you have an idea of how we are trying to approach this important topic. When you read my response, please also keep in mind that I have had several reports that a very small number of people may not be following proper social distancing protocols when using our parks. I am again asking all residents to please continue to social distance in our parks, as this is a time for us all to be both vigilant and considerate of the greater community. I would hate to have a few people's thoughtless behavior result in us having to reexamine our ability to keep the parks safe and available to all during this very challenging time. Thank you for your ongoing support and cooperation.

Dear Concerned Resident,

Thank you for your letter of concern regarding the Fair Haven Parks. I believe that you may have misinterpreted the Facebook post. Our parks have remained open throughout the crisis and we do encourage people to go outside and take in fresh air for the sake of mental and physical health. In our parks, we have closed off all touchable surfaces, including playgrounds, tennis courts, basketball hoops and all bathroom facilities. Additionally, our water fountains will remain winterized until it is deemed safe to turn on the water. Our police department is closely monitoring all parks for volume of people and general behavior compliance. In addition, we have posted the attached sign in all parks, reminding residents to maintain social distancing.

Governor Murphy's decision to close all State and County parks came from a single report from the State Park Police that some parks had been overrun with not only residents, but an inordinate amount of non-residents. Many shore towns have taken similar precautions and closed their boardwalks and beaches. The concern driving these decisions is that the volume of people would make social distancing impractical. Governor Murphy left the decisions regarding Borough Parks to the discretion of the local governing bodies.

The discussion of our park facilities has been an ongoing and daily agenda item since the beginning of the crises. After consulting with our Councilmembers, Administrative Staff, Health Department and our OEM coordinator, we believe that the Fair Haven Parks afford the space and opportunity for proper social distancing and full adherence to the CDC guidelines. The use of masks by all was not recommended by the CDC just a few weeks ago. As this crisis has progressed, that guidance has evolved and the use of masks is now required in NJ when people enter stores or locations where social distancing is hard to maintain. At this point in time, we have not witnessed or had any reports of issues regarding social distancing in our parks. We will continue to monitor our parks and we will adjust our policy based on changing information or official guidance.

OUTDOOR LIVING PROJECTS:



DO ALL LANDSCAPE PROJECTS REQUIRE A ZONING OR BUILDING PERMIT?

Not necessarily. If your landscaping project is limited to the planting of grass, plants, flowers, bushes, shrubs and trees, then no Zoning (or Building) Permit is required. All planting must be within the property lines and not in the Borough Right of Way.

However, once you start to add other “outdoor living” features, you are required to submit a Zoning Permit Application first. These projects would include, but not be limited to the following: Outdoor Kitchens, Outdoor Fireplaces (roofed or unroofed), Pools, Patios / Decks, Ponds, Fire Pits, Gazebos, Sheds, etc.

Some of these (Additions to the house, Pools, etc.) are obvious construction projects that require approved Zoning and Building Permits to proceed. The other “hardscaping” projects may be less obvious to the average homeowner.

WHY DO I NEED A ZONING PERMIT FOR HARDSCAPING PROJECT?

Hardscaping features includes such things as Ponds, Patios (Pavers, Concrete, or other), Fire Pits, Gazebos, Sheds, etc. All of these require an Approved Zoning Permit Application prior to beginning any work. Do NOT believe any landscaper who tells you that a permit is not required for such work, as this could be a mistake that may end up costing you additional time and money.



The reason a Zoning Permit Application is required for hardscaping is that these projects involve a change to your lot coverage, which is calculated based on a percentage of your total lot area, which varies by zone. Proceeding with a hardscaping project without an approved Zoning Permit is in and of itself a violation of our zoning ordinance, even if the project would otherwise be allowable under the Borough's zoning codes.

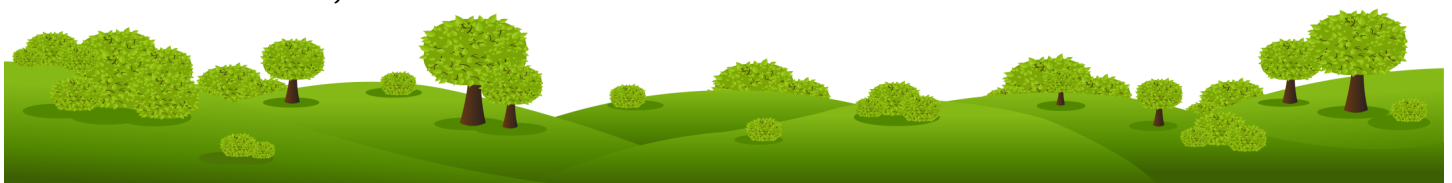
If your project creates a situation whereby your lot coverage exceeds what is permitted in your zone, Borough ordinances would require that the violation be eliminated/removed. Alternatively, you would be required to go before the Zoning Board of Adjustment to apply for variance relief from any potential zoning violation, which is a process that takes time and has related costs. Lastly, and perhaps most important is the fact that the violation could even complicate your ability to sell your home in the future.

WHO CAN I CALL TO GET GUIDANCE?

To avoid this potentially difficult situation from the start, please talk with one the Borough's Zoning Officers and file a Zoning Permit Application. The Zoning Office stands ready to assist our residents and we will do our best to make the zoning application process as easy as possible so you won't face any unexpected issues in the future.

WHAT IS STORMWATER POLLUTION?

Water from rain and melting snow that flows over lawns, parking lots and streets is known as stormwater runoff. This water, which travels along gutters, into catch basins and through storm drain pipes and ditches, usually is not treated, but then flows or is discharged into local water-bodies. Along the way, the stormwater picks up trash (fast-food wrappers, cigarette butts, styrofoam cups, etc.) and toxins and other pollutants (gas, motor oil, antifreeze, fertilizers, pesticides and pet droppings). This polluted stormwater can kill fish and other wildlife, destroy wildlife habitat, contaminate drinking water sources and force the closing of beaches because of health threats to swimmers.

Human activity is largely responsible for the stormwater pollution. Everything that we put on the ground or into the storm drain can end up in our water. Each of us has a responsibility to make sure these contaminants stay out of our water. **Whether we have clean water is up to you!**

Here are some simple guidelines to follow:

- Follow the directions on the fertilizer bag, do not apply before it rains and use only when necessary.
- Properly dispose of your pet's waste by flushing it down the toilet or by placing it in a bag and throwing it in the trash.
- Recycle used oil at certified facilities and maintain your vehicle to prevent leaks.
- Take your car to a car wash where the water gets treated and recycled

IMPORTANT BRUSH AND/OR LEAF PICK UP FACTS:

- It is very important that residents put brush and/or leaves to the curb no later than the weekend prior to your designated zone's pick up week.
- The DPW will pick up brush and leaves only one time on your street, for each designated week. Place brush and/or leaves to the curb no later than the Sunday night of your respective pick-up week.
- The DPW crew only does one pass on each street during your pick-up week. Once they pick up on your street, they will not return anytime later that week.
- If you miss the pick-up day on your street, or if you have additional brush and/or leaves after your street has been picked up, please keep the brush and/or leaves on your property, as opposed to in the street, until the weekend before your next designated pick-up week.
- All Landscapers are required to register annually with the Borough, at which time they are given a copy of our zone brush and leaf pick-up schedule to follow. Please speak to your landscaper and reinforce the need to follow the zone pick up schedule

Home Security:

With the warmer weather approaching, many homeowners will begin to open their windows and sliding doors to allow the fresh air into their homes. An open window or slider, especially on the first floor, is an easily accessible entry point for any burglar looking for an “easy score”. Remember to close and lock these windows and doors every time you leave your home, even if it's only for a quick milk run to the Acme. A burglar only needs a few minutes to enter your home and steal your valuables.

Fraud Alert

It's inevitable that scammers/fraudsters will find new ways to profit from the COVID-19 pandemic. They continually prey on the vulnerable and the kindhearted people of our society and will use this pandemic to their advantage. Don't become a victim!

Be vigilant if you're making online purchases for items such as sanitizer, bathroom tissue, and personal protective equipment. Try to use reputable websites that have consumer protections in place.

Be vigilant if you're solicited for donations or looking to make a donation. Donate to local charities and/or online charities that you are familiar with.

Don't provide your credit card number, social security number, bank account number, birth date, etc to anyone unless you are positive that they need that information for a legitimate reason.

Don't make payments in the form of gift card purchases. Scammers often request their victims to purchase gift cards such as eBay, iTunes, and GreenDot from their local convenience stores and to call them back with the card numbers. This is not how legitimate businesses request payment.

If you feel that you've been the victim of fraud, contact the police department to make a formal report. An officer will guide you through steps you can take in the hopes of minimizing any potential damages.



Water safety needs to be practiced at all times. Whether you are at the beach, near a swimming pool or on a boat, make sure that children are watched at all times and flotation devices are available if they do not know how to swim.

Practicing water safety will help make your summer more enjoyable and relaxing.
