THE AWARDS

The South Carolina Housing Achievement Awards are presented to recognize outstanding contributions in the area of affordable workforce housing for low- and moderate-income South Carolinians. The Housing Achievement Award honorees will be announced at the 2026 Affordable Housing Summit scheduled for April 15-16 at the Columbia Metropolitan Convention Center.

ELIGIBILITY

Individuals and organizations are eligible for nomination. The work honored must have resulted in affordable workforce housing in South Carolina. Nominees must be in good standing with the SC State Housing Finance and Development Authority. Commissioners and Staff members of the South Carolina State Housing Finance and Development Authority are not eligible.
