- Presale Sales Begin December 1, 2016. Contract and Payment in full must be received by January 16, 2017
- Presale Contract not Paid in Full by 01/16/2017 will default to the regular sale price.
- During the presale period all previously occupied (2016) spaces will be reserved for <u>same</u> Vendor occupancy
- Vendors may only presale previously occupied space
- Members must be up to date on renewal and in good standing to qualify for member discount
- Non-Member Vendors wishing to join as a member must pay membership in full prior receiving member rate
- Regular Sale begins 1/17/2017 All booths not sold during the presale will then be available to <u>all</u> vendors (unpaid booth spaces will not be reserved)
- Basic Electricity and Forklift Rental included w/booth space at no charge
- Landline & Ethernet \$25.00
- All booths are 10' x 10, price includes pipe, drape & basic electricity.
- For Members: Personal Page with summary, logo and link to Member website on VT Home & Garden Show Site, included in Advertising Inserts & Map and Receive 10% off Ad Space
- Booths must be paid in full; cancellation refunds will be at the discretion of HBRANV
- No space can be reserved without completion of this Contract, Payment in Full & Proof of Insurance
- Both the Exhibitor and the Billing Company must provide Certificates of General Liability
- HBRANV reserves the right to provide discounts, decline request for space, reassign booth spaces & change show start/end times
- Please email, fax or mail contract
- Booths will not be reserved until both contract & payment have been received
- Most Corner Booth Locations are Sold Out during the presale period
- All effort will be made to place regular sale Exhibitors away from "like" Vendors but this cannot be guaranteed
- Each Exhibitor can receive up to five (5) exhibitor badges per contract and will receive ten (10) admission tickets.
- Exhibitor badges are for the sole use of personnel working the booth.
- The Exhibitor Contact is responsible for providing their booth staff with badges, they cannot be left for individual pick-up.
