WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. "In consideration for participating in Festival of Whales Street Fair and other valuable consideration, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO the Pet Project Foundation, Festival of Whales Committee, Dana Point Harbor Partners & Burnham Ward Properties, and the City of Dana Point, their officers, servants, agents, and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.
2. To the best of my knowledge, I can fully participate in this activity. I am fully aware of risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I hereby elect to voluntarily participate in said activity, and to enter the above-named premises and engage in such activity knowing that the activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such an activity, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise.
3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage or costs, including court costs and attorney's fees, that may incur due to my participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.

It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs, assigns and personal representative, if I am not alive, shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of California.
5. I UNDERSTAND THAT PET PROJECT FOUNDATION WILL NOT BE RESPONSIBLE FOR ANY MEDICAL COSTS ASSOCIATED WITH AN INJURY I MAY SUSTAIN.
6. I also understand that I should and am urged by the Pet Project Foundation to obtain adequate health and accident insurance to cover any personal injury to myself which may be sustained during the activity or the transportation to and from said activity.
7. I ALSO UNDERSTAND THAT I AM RESPONSIBLE FOR ANY DAMAGE I CAUSE TO THE FACILITIES. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

EVENT HOURS

Saturday, March 7, 2020 - 10:00am – 4:00pm

EVENT LOCATION

Dana Point Harbor, the intersection of Golden Lantern and Dana Point Harbor Drive.

BOOTH SPACE

Each booth consists of a 10'x10' space. All expo vendors must have a clean, white solid colored and in good condition canopy. Canopies can be ordered at an additional cost. Additional fees apply for electricity. Vendors selling any items must have a seller's permit and provide a copy with a completed application.

LOAD IN & LOAD OUT HOURS:

Load In Saturday, March 7 – 7:00am – 9:00am

Load Out Saturday, March 7 – 4:00pm – 5:30pm

Load In: Upon arrival, please check in with event staff in the parking lot in front of El Torito (34521 Golden Lantern St, Dana Point, CA 92629). Once you are checked in, we will direct you to your booth. Please unload your equipment as soon as possible near your assigned booth location. Because we have over 70 vendors, you will need to unpack your booth materials and then move your vehicle before setting up your booth. Parking will be provided in a nearby lot and a shuttle will be provided. PPF Volunteers will be on-site and will be monitoring your belongings while you set up.

All vehicles must be removed from the Dana Point Harbor by 9am. Access to the Harbor parking lot will be closed at that time and no vehicles will be allowed access until 4:00pm on Saturday evening.

Load Out: Breakdown begins at 4:00pm. No early departure. If a vendor leaves the event prior to 4:00pm, it may affect future participation in the Street Fair.

Please stay in your booths for the duration of the Street Fair.

The Street Fair is a rain or shine event, even with inclement weather, the event will still take place and as noted in your application no refunds are issued.

RESTROOMS

Portable restrooms will be available on the event site. Sinks will also be available for you to wash your hands.

TRASH/REFUSE

Please remove all trash, waste, boxes, etc from your booth. A fee of \$100.00 will be charged to any vendor who damages public property, leaves trash or puts trash in sinks.

If you are traveling from NORTH of Dana Point:

Take the I-5 south, exit Pacific Coast Hwy. Stay in the right hand lane of the exit ramp and go north on Pacific Coast Highway. Turn left onto Dana Point Harbor Drive and then turn left onto Golden Lantern. Enter the parking lot at the end of the road (the second right hand turn) closest to El Torito. Make sure to display your Vendor Pass to the on-site security/volunteers in order to be allowed onto the lot. ***All vendors must enter the parking lot near the El Torito entrance and check in with staff.***

If you are traveling from SOUTH of Dana Point:

Take the I-5 north, exit Beach Cities. Stay in the left lane of the exit ramp and go north on Pacific Coast Highway. Turn left onto Dana Point Harbor Drive and then turn left onto Golden Lantern. Enter the parking lot at the end of the road (the second right hand turn) closest to El Torito. Make sure to display your Vendor Pass to the on-site security/volunteers in order to be allowed onto the lot. ***All vendors must enter the parking lot near the El Torito entrance and check in with staff.***

PARKING

Parking will be provided in a nearby lot and a shuttle will be provided to and from the street fair location. Additional information will be provided to you once you confirm your vendor spot, closer to the event date. Please note that Dana Point Harbor Drive will be closed until at least 12:30pm for the Festival of Whales Parade and no cars will be permitted on Dana Point Harbor Drive between 10am - 12pm. Ensure that all of your employees/booth staff are onsite prior to that time.

ELECTRICITY:

Please note that if you requested and paid for electrical services, you will receive a 110-amp, 1-plug outlet with each electrical request. ***Please note that you need to bring your own extension cords!***

Vendors will hold Pet Project Foundation, The Dana Point Chamber of Commerce, the City of Dana Point, Festival of Whales, Dana Point Harbor Partners, Burnham Ward Properties and any sponsors of the event, harmless from any and all liability whatsoever as a result of any acts and or any loss of property at the event.
