To be an effective Supervisor for the County and particular advocate for District 4, I will always diligently review all information and research available to me and I will seek input from a range of experts, stakeholders and community members in an effort to make well-informed decisions that will benefit District 4 residents and the County as a whole.

Stabilizing Families

As a County, our culture is to lead by example. We are the **third largest employer** in Silicon Valley —behind only Apple and Google. Providing our workforce – approximately 20,000 Santa Clara County residents – with access to affordable, quality child care will help not only stabilize our families but also have a positive impact on our children's success in school, within their communities, and their overall preparedness for the Silicon Valley workforce.

That's why I directed the County Executive Staff to report to the Board of Supervisors on a work plan for implementation of onsite child care at one or more County facilities and an increased child care subsidy for child care for County employees to be implemented during the 2019–20 fiscal year.

Empowering Foster Youth

Santa Clara County is dedicated to supporting foster youth and seeing that they are successful citizens. It was with this in mind that my colleagues and I on the Board of Supervisors voted to extend the Summer Intern & Earn Program to Learn, Earn, And Progress (L.E.A.P.), year-round paid internship program. This program will help foster youth ages 18–24 acquire the skills needed to enter the workforce.
