CERTIFIED RESULTS OF REFERENDUM AGAINST ORDINANCE NO. 188610

(INCREASING WAGES AND HEALTHCARE BENEFITS FOR HOTEL AND AIRPORT WORKERS AND HOTEL WORKER TRAINING)

LOS ANGELES (**September 8, 2025**) — Los Angeles Interim City Clerk Petty Santos announced that the Referendum Petition Against Ordinance No. 188610 (Hotel and Airport Worker Benefits), does not contain the number of valid voter signatures required under the City Charter, and therefore the referendum petition has been certified **insufficient**. Under Charter Section 461, the Ordinance shall take effect upon the date of the Certificate of Insufficiency, which is September 8, 2025.

Proponents filed a referendum petition against Ordinance No.188610 on June 27, 2025. The Los Angeles County Registrar-Recorder/County Clerk (County) was responsible for examining the signatures on the referendum petition.

Under the Charter, proponents of the referendum petition were required to collect a minimum of 92,998 valid voter signatures. Based on the County's examination, 84,007 signatures were found to be valid and 56,767 were found to be invalid. Therefore, the petition has failed to meet the sufficiency requirements of the City Charter.


A summary of the results of the County's examination of the petition is included in the attached Petition Statistics Report. The Office of the City Clerk issued the Certificate of Insufficiency on September 8, 2025.

Under the City Charter, Ordinance No. 188610 had been suspended and did not take effect while the referendum petition was being reviewed. That review is now complete and the referendum petition has been certified insufficient. Under City Charter Section 461(c), Ordinance No. 188610 is effective as of the date of the certificate of insufficiency, which is September 8, 2025.
