Substances like ketamine and psilocybin are being studied for their ability to modulate pain perception, reduce neuroinflammation, and ease the emotional burden of chronic suffering. Today’s research is peer-reviewed and clinically relevant, building on early LSD studies and advancing through cutting-edge trials at institutions like Johns Hopkins and Yale. The science is catching up to the potential. Join us for a compelling panel discussion at the intersection of neuroscience, psychiatry, and emerging therapies. We’ll separate facts from hype and explore how to talk about these treatments with clarity and confidence.
