STANDARDS FOR RETURNING TO THE SANCTUARY FOR SERVICES

Upon return to the sanctuary for services, be aware of the following changes that are instituted to reduce the risk of COVID-19 transmission.

- We will only have Friday night and Saturday morning services.
- You must preregister for services and attest to a brief health survey.
- You must be 8 years or older to register and attend services.
- Individuals with risk factors for serious disease should they contract COVID-19 should consider continued attendance through online transmission, which will remain available.
- Chairs are arranged in seating groups of 2, 3, and 4, with 10 ft. of separation between groups.
- Maintain social distance (6 ft.) between unrelated individuals.
- Masks will always be required in the building except for the service leader.
- There will be a Plexiglass barrier around the service leader.
- Hand sanitizers will be available throughout the building.
- Bring your own yarmulke; separate prayer books will be available for Friday night and Saturday services.
- Because the risk of transmission with singing is uncertain, congregants are asked to sing no louder than a spoken voice.
- Recommendations are for one person at a time to use restroom facilities. Wash your hands thoroughly with soap and water after using the facilities.
- No food will be served in the building; please do not bring any food with you.

Before returning to the sanctuary for services, you must preregister for the service you wish to attend and read and agree to the following guidelines that are established to reduce the risk of contracting or spreading COVID-19:

- Be 8 years or older
- Agree to wear a mask at all times in the building
- Adhere to social distancing guidelines (6 feet separation) in the building; seating groups are set up to maintain 10 feet separation between groups
- Sign a waiver. These procedures and guidelines are meant to reduce the risk of contracting COVID-19 but cannot ensure that you will not get infected.
- **Attest that you:**
 - Have not experienced flu-like symptoms, including, but not limited to, fever, shortness of breath, cough malaise, loss of taste or smell, in the last 14 days.
 - Have not, yourself or anyone in your household, been diagnosed with Covid-19 or been exposed to someone with Covid-19; or, if yes, have been tested again and received a negative test result for Covid-19 or are more than 14 days without symptoms or fever after the diagnosis or exposure.
 - Have not traveled via the airport in the last 14 days.

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Flemington Jewish Community Center (FJCC) has put in place preventative measures to reduce the spread of COVID-19; however, the FJCC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the FJCC could increase your risk and your family's risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the FJCC and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the FJCC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the FJCC employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my attendance at the FJCC or participation in the FJCC programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the FJCC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the FJCC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any of the FJCC's programs.
