## **2020 PPRA PPRA Fast-Track Award Criteria**

### **Nomination Criteria**

1. Nominee must be an active member of PPRA.
2. Nominee must be an active practitioner of public relations in the Philadelphia region.
3. Nominee must have a track record of successful programs and contributions to the organization he/she represents. These contributions must be clearly outlined in the nomination form essay and the nominee's resume.
4. Nominee must have a track record of continuing public service and at least one leadership role. Public service contributions must be listed on the nomination form.
5. Nominee must have five-eight years of professional practice in the public relations field.
6. Nominee must have at least three references from superiors/peers/clients attesting to his or her professional performance and integrity.
7. Nominee cannot be a current member of the PPRA Awards Committee.
