PARENT/GUARDIAN and STUDENT AGREEMENTS

- I understand and agree to the following policies and provisions of my/my child's participation in the Mills High School 2018 Grad Night party.
- I understand that this event is a parent volunteer committee activity and is not a school or district organized event. The school and school district accept no responsibility for the activities of the Grad Night event.
- I hereby release and hold harmless the San Mateo Union High School District, Mills High School, the Viking---Parent Group, aka Mills Viking Parent---Teacher Organization (PTO), the members of the Mills Grad Night Committee and the company providing the Grad Night site, as well as the employees, officers, board of directors, members, agents, representatives, and volunteers of the aforementioned entities, for any loss, damage, cost or expense (including attorney's and expert fees) with respect to any such loss, damage, cost, or expense which may arise as a result of or in connection with my/my child's participation in this event, whether the same shall arise by the negligence of any such persons or entities or otherwise.
- I understand that Grad Night is a drug-free and alcohol-free graduation party sponsored by the Mills High Grad Night Committee which will be held on June 8, 2018.
- I agree that I/my child _____ will not carry on the bus or into the park premises any materials, drugs, or alcohol which will affect my/his/her behavior and/or will have an effect on the behavior of others. I understand and agree that if I/my child is found with any such materials, drugs, or alcohol which will affect my/his/her behavior or of others, I/he/she may be turned over to the authorities of the local Police Department. Students/Parents who appear to be under the influence of alcohol or other drugs will not be permitted to board the bus and payment will not be refunded.
- I understand and agree that I/my child is being transported by bus from Mills High School (meet at 5:00am, June 8) to the site and from the site (approximately 2:30am, June 9), and back to Mills High School returning at approximately 10am on June 9. I understand the Grad Night Committee is not responsible for persons failing to check in by 5:30am on June 8, 2018, and understand that the Grad Night Committee will not compensate or reimburse for costs incurred. No private cars will be allowed and anyone who does not ride the bus will not be admitted to the event.
- I understand that it's expected that students shall participate in the whole evening (bus rides to and from the event). Students will NOT be allowed to leave unless accompanied by parent or guardian by prior written arrangement.
- I understand and agree that I/my child will act as a responsible individual, in an acceptable manner, while a guest at Grad Night. If at any time my/my child's actions become unacceptable to other guests, the management of the site and/or the Grad Night Committee, they reserve the right to detain me/my child and the parent/guardian will be contacted immediately. It is also understood and agreed that the parent/guardian will have to make arrangements to transport me/my child home at their expense. Additionally, I understand and agree that the Grad Night Committee is in no way responsible for my/my child's subsequent actions should I/he/she leave the premises without their knowledge and/or permission.
- I assume full financial responsibility for any and all damages that may result from any irresponsible actions on the part of me/my child to the bus, the premises, any other guest, the management of the site and/or the Grad Night Committee.
- I understand that at this event or related activities, I/my child may be photographed. I agree to allow my/my child's photo, video or film likeness to be used for any legitimate purpose by the event holders, organizers or assigns.

Grad Night Code of Conduct – 2018 – Universal Studios

Code of Conduct

Welcome to Universal Studios Hollywood and Universal CityWalk ("Universal").

In order to ensure that your visit and that of your fellow guests is pleasant, we request that all visitors to Universal comply with the following Code of Conduct:

1. Do not physically or verbally threaten or harass any person. Fighting, use of physical force, obscene or sexually explicit language or gestures, or racial, religious or ethnic slurs, including any display on apparel or via body art likely to create a disturbance or a danger to other persons, are prohibited.
2. Do not possess any item that could be used as a weapon, including, but not limited to: firearms, explosives, fireworks, clubs or sticks over 1/4 inch in diameter, chemical dispensing devices, knives with blades over 2 inches in length, or any other object(s) that may be used in any way to inflict bodily injury on another person.
3. Do not yell, scream, sing, play musical instruments, radios, audio players or other sound amplification devices, or otherwise communicate in a manner which creates noise of sufficient volume to disturb the ambient noise level of Universal or impinge on the hearing or peace of other persons beyond a ten (10) foot radius.
4. Visitors must be fully clothed, including shoes and shirts. Visitors may not wear any covering that fully or partially obscures a person's face unless for religious or medical reasons. Clothing that Universal construes as indecent, exposes excessive portions of the skin, or that Universal views as inappropriate for a family environment is prohibited.
5. Do not run, skate, rollerblade, skateboard, ride a bicycle or scooter, or use wheeled shoes. Do not obstruct or interfere with the free flow of pedestrian traffic.
6. Do not discard litter of any kind except in designated trash receptacles. Rummaging through or removing items from the trash receptacles or coin fountains are prohibited. Spitting is prohibited. Urinating anywhere except at designated restrooms is prohibited.
7. Do not deface, damage or destroy any property belonging to Universal, its merchants or other persons.
8. Use or possession of any illegal substances or paraphernalia is prohibited. Smoking is not permitted during this event.
9. No photographing or videotaping for commercial purposes without Universal's prior consent. No photographing or videotaping in a manner that is harassing or disruptive to Universal's merchants or other persons.
10. Do not solicit money or other contributions or donations, or sell admission tickets to CityWalk and/or Universal Studios Hollywood or Gibson Amphitheatre, or distribute commercial advertising or promotional material of any kind, or offer samples of items which are sold or available for sale.
11. Do not sit on handrails, stairs, escalators, trash receptacles or other areas not specifically designed for sitting. No occupied wheelchairs are allowed on escalators.
12. Do not bring any animals on to Universal's property with the exception of service animals providing assistance to disabled persons and/or in the company of persons claiming to be a trainer of a service animal.
13. Daytime curfews (Los Angeles Municipal Code 45.04) and nighttime curfews (Los Angeles Municipal Code 45.03, unless accompanied by an adult after 10:00 p.m.) will be enforced.
14. Line jumping where the use of a queuing system is employed is prohibited.
15. Coolers, food purchased off of the property, any container or vessel containing food or any container of beverages is not permitted in the park. Exceptions may be made in advance for medical, special dietary or religious reasons only (see medical form).
16. All bags, backpacks and purses are subject to inspection by Universal security without advance notice and should not be left unattended.
17. Do not violate any federal, state or local law or ordinance. Failure to comply with all posted rules, signs, warnings and policies is prohibited.

Violators of this Code of Conduct will be asked to leave the Universal's property and may be cited for trespass or violation of local, state or federal law and/or may be arrested by local law enforcement agencies
