<b>Eligibility</b>	To qualify, applicants must: <ul style="list-style-type: none"><li>- Have a gas bill in their name and received a final shut off notice or have been disconnected</li><li>- Have exhausted all other energy assistance funds</li><li>- Be responsible for paying their heat bill</li><li>- Have a bill under \$1000</li><li>- Have paid 3% of the household annual income towards the balance</li><li>- Have a critical event (crisis or emergency) that has prevented them from paying the bill</li><li>- Live anywhere in Minnesota</li></ul>
