# Introduction

Welcome to the course catalog from Los Angeles County Department of Homeless Services & Housing (HSH). The HSH Training Team's mission is to deliver transformative educational opportunities that enhance, support, and empower the HSH workforce and community partners to achieve knowledge and skills that will improve the lives of the people, families, and communities they serve. Our team serves HSH, Office of Diversion and Reentry, the Harm Reduction Division, and all of our community providers.

HSH Training Team offers a wide range of trainings both for internal staff and external staff at contracted community providers. We have nearly 45 training sessions per month, including trainings on motivational interviewing, documentation, trauma-informed care, and much more. We facilitate these trainings in person, online, and through e-learning platforms.

Registration is done through our learning management system, TalentWorks. Upon successful completion of a course, your attendance will be recorded and you will be able to print your certificate. Attendees should stay for the entire course and complete a quiz if required or they may not be marked as complete. Thank you for your interest and we look forward to supporting your professional development.

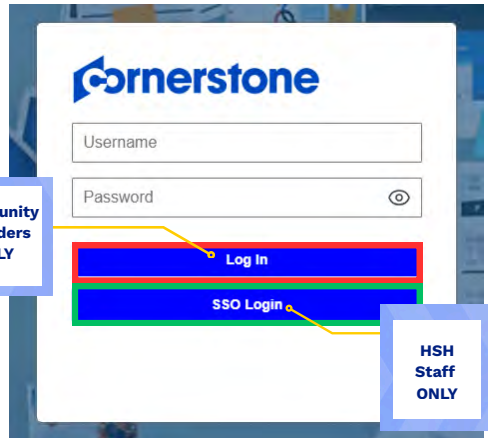

The department was formed following a [motion](#) passed by the Los Angeles County Board of Supervisors in April 2025 and was officially launched January 1, 2026.

We strive for just and equitable housing and services for all LA County residents.

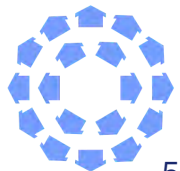
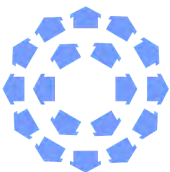

**Office of Diversion and Reentry  
and Harm Reduction Division**

**OFFICE OF DIVERSION  
AND REENTRY**

The Office of Diversion and Reentry (ODR), within the Los Angeles County Department of Health Services, develops and implements programs to divert people with serious mental, physical and/or behavioral health needs away from the LA County jail system and into community-based care, including access to interim and permanent housing solutions.

Since it began in 2015, ODR has launched many successful innovative programs, helping to safely remove thousands of individuals from the jail system and supporting thousands more who have been released from incarceration or are on probation supervision in the community.



The **Harm Reduction Division** collaborates with communities to support health and wellness services, promote education, and advance policies for the health, dignity, and agency of people who use drugs, experience homelessness, are justice-involved, or are engaged in sex work. The division supports direct services, including outreach, overdose response teams, drop-in spaces, contingency management, drug checking, and naloxone distribution in jails and throughout LA County. Additionally, they focus on capacity building and training, including workforce development programs, training for community members, housing services, and healthcare providers, and maintain a clearinghouse for harm reduction supplies and naloxone. The division also supports community engagement with listening sessions and a county-wide Harm Reduction Steering Committee.

# Documentation Series

## Training Overview

Welcome to the Documentation Series, a comprehensive training program comprised of three essential sessions: the 5x5 Assessment & Housing Acuity Index (HAI), Care Plans, and Services & Case Notes. This series is mandatory for case managers and supervisors in HSH and ODR programs to ensure strict adherence to LA County Policies and Procedures. Each training session includes a quiz, and participants must achieve a minimum score of 70% to successfully complete the course. Registration for the series is facilitated through TalentWorks.

The 5x5 Assessment Training aims to provide in-depth instruction on administering 5x5 Assessments. Attendees will receive detailed guidance on identifying the assessed domains and understanding scoring procedures. This training is designed to equip attendees with the knowledge and skills to proficiently conduct 5x5 Assessments.

In the Care Plan Training, participants will be guided through the process of developing participant care plans based on the 5x5 assessment scores and creating SMART goals with aligned action steps. Several examples will be provided to aid in visual comprehension. Emphasis will also be placed on policy compliance and the essential frequency of care plans.

Finally, the series concludes with the Services and Case Notes Training. This session will provide a comprehensive understanding of the services offered, their definitions, and their application to the CHAMP system. The training will underscore the significance of documenting services with a case note, along with a review of case notes and their formats.

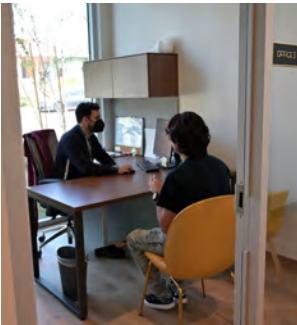

Effective case management is crucial for enhancing the quality of care and ensuring successful outcomes for participants.

The **Case Management Support** section of our training catalog is designed to provide comprehensive education and resources for community providers and partners working in **HSH** and **ODR**.



This section offers a diverse selection of training sessions that address critical aspects of case management and working with program participants, from understanding healthcare systems to dealing with complex participant behaviors.

These training offerings are designed to equip case managers with the knowledge and skills necessary to navigate the complexities of participant care. By participating in these sessions, case managers can enhance their competencies, improve participant outcomes, and foster a more supportive and effective care environment.



# Trainings At a Glance

- **Accessing Healthcare: Medi-Cal Expansion & Updates** - Covers recent changes and expansions in Medi-Cal to better assist clients in accessing essential healthcare services.
- **Basic Landlord/Tenant Rights** - This workshop is designed to provide you with foundational knowledge of landlord/tenant law and the eviction process so you can better support clients who may be at risk of displacement or dealing with housing instability
- **Boundaries in the Workplace** - Trauma-informed and harm reduction approaches to boundaries, ensuring interactions with participants and community members remain person-centered while maintaining professional integrity.
- **Cultural Humility Capacity Building** - Develop cultural awareness to serve diverse communities by examining power and privilege within institutional structures and skill-building to provide affirming care.
- **Data Quality Essentials: Small details, Big Impact:** Discover practical strategies to ensure assessments, care plans, and case notes are clear, consistent, and impactful. This training empowers case managers to effectively showcase their work and document client progress, highlighting the meaningful outcomes achieved through quality care.
- **Engaging People Who Use Drugs - A Harm Reduction Approach** - The whys of substance use and how to compassionately & collaboratively support individuals using substances.
- **Engaging Pregnant People Experiencing Homelessness (PEH)** - This training provides practical tools and communication strategies to help providers engage pregnant people experiencing homelessness, discuss resources, and support their reproductive health goals
- **Fair Housing and Reasonable Accommodations/ Disability** - This workshop is designed to provide you with an essential overview of fair housing protections and focuses on how to assist clients—particularly those with disabilities—in asserting their rights and requesting reasonable accommodations to maintain stable housing.
- **Harm Reduction and Stages of Change** - Understanding harm reduction principles and the stages of change to effectively support clients in community settings.
- **Hoarding Workgroup** - Approaches to managing and supporting clients with hoarding behaviors within community programs.
- **Intimate Partner Violence** - Comprehensive training on identifying, addressing, and supporting clients experiencing intimate partner violence (Part 1 and Part 2).
- **Journey from In-Home Care Giving to In-Home Support Services** - Educates participants on accessing and applying for both the IHCG and IHSS caregiving programs in LA County, detailing the differences between these distinct programs while also covering available resources and best practices for supporting clients with Activities of Daily Living (ADLs).
- **Los Angeles Housing Assessment Tool (LA HAT)** - The Los Angeles Housing Assessment Tool (LA HAT) is the new CES triage tool for adults that replaces the former VI-SPDAT/CES Survey for Adults. The purpose of the LA HAT is to assess a person's vulnerability to possible adverse events while experiencing homelessness. It will be used to assist with connections to services and housing.
- **Liberty Harm Reduction** - Learn what harm reduction is and how to actionize it.
- **Motivational Interviewing** - Multi-part series (Parts 1-3) covering basic techniques, advanced strategies, and continued development and refinement of motivational interviewing skills to enhance client engagement and motivation.
- **Overdose Education and Naloxone Distribution (OEND)** - Now offered in English and Spanish - Recognizing, responding to and reversing opioid overdoses, and distributing naloxone.
- **Question, Persuade, Refer (QPR - Help Prevent Suicide)** - Includes when and how to screen for suicide risk in your work setting (if appropriate) and how to support someone in crisis. More, you will learn to identify and arrange an expert referral for evidence-based suicide-specific assessment and treatment.
- **Substance Use Disorder (SUD) 101** - Tailored for staff who are new to supporting people who use drugs. Learn more on factors that lead to SUD 101 & how to have conversations around it.
- **Tenant Protection (State and Local Protections):** This workshop focuses on rent stabilization, just cause eviction protections, and recent state laws. It equips participants with practical knowledge to help prevent unlawful evictions and promote long-term housing retention for clients.
- **Trauma-Informed Care** - Introduction to trauma-informed care principles and advanced concepts for supporting clients with complex trauma histories (Part 1 and Part 2).
- **Trauma-Informed De-escalation & 911 to 211** - Trauma-informed de-escalation strategies and transitioning crisis responses from emergency services (911) to community-based support systems (211).
- **Understanding Client Mental Health** - Recognizing and addressing various mental health issues within the context of community programs.
- **Working with Difficult Client Situations & Client De-escalation** - Techniques for managing challenging client situations and effective de-escalation strategies.

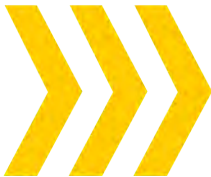
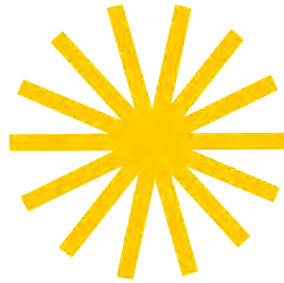

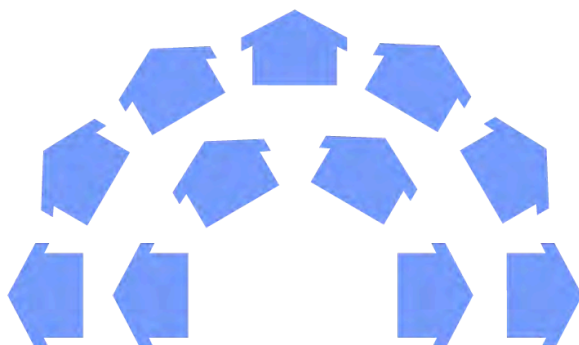
