



EDUCATION PROGRAM MINOR WAIVER

Being the parent or legal guardian of the summer camp participant(s), I hereby give my consent to allow my (son, daughter, ward) to tour the facility and participate in camp activities including those related to animal interaction with the Foundation and Aquarium. I fully understand and acknowledge that his/her participation in camp activities are subject to all the rules and regulations of the St. Louis Aquarium, that violations thereof shall be cause for immediate dismissal from camp and that all activities participated in by my (son, daughter, ward) are strictly voluntary, without pay and compensation of any sort and without liability of any nature on behalf of the Foundation and Aquarium.

I further acknowledge that all activities participated in are performed at his/her own risk. On behalf of myself, my (son, daughter, ward), my heirs, my personal representatives or administrators, I hereby release, discharge, indemnify, and hold harmless the Foundation, USH Aquarium, LLC dba St. Louis Aquarium at Union Station and St. Louis Aquarium, USH Attractions, LLC, Lodging/Hospitality Management Corporation, LM Services Corporation, and each of their members, managers, directors, officers, shareholders, employees, agents, affiliates, subsidiaries, insurers, representatives, successors and assigns (collectively all of the foregoing are the "Aquarium Parties") from and against any claims, including claims for personal injury, death, economic damage and or property damage, causes of action, liabilities, losses, demands, judgments, or fees, which could in any way be associated with or connected with my child's participation in activities as a registered participant in a program with the Foundation and Aquarium, including but not limited to, animal bites, accidents, or injuries, regardless of the negligence or fault of the Aquarium parties and medical treatment administered by the Aquarium Parties during his/her participation in the program.

I understand that public relations are an important part of promoting the Foundation and Aquarium. On behalf of myself and my (son, daughter, ward), I allow the Foundation and Aquarium to use any photographs or videos taken of my (son, daughter, ward) for use in public relations efforts. I hereby grant and convey unto the St. Louis Aquarium Foundation and the St. Louis Aquarium at Union Station all right, title and interest in any and all photographic images and video or audio recordings of my son, daughter or ward made by the St. Foundation and/or Aquarium, including but not limited to, any royalties, proceeds or other benefits derived from such photographs, videos or recordings, and hereby waive and release on behalf of myself or my son, daughter or ward any right to such royalties, proceeds or benefits.

By completing camp registration, I agree to the above terms and release liability.

Camp Consent Form

- Camp participants may come into contact with shellfish, soy, milk, nut, and wheat products.
- All camp participants are required to wear closed toed shoes for their safety. Camp participants who arrive with open toed shoes will not be allowed to participate in activities.
- Camp participants will come in close contact with animals on a daily basis. Animals may include (but are not limited to) reptiles, birds, small mammals, fish, and invertebrates.
- Families will be responsible for providing a lunch and drink for their child for each day of camp. Refrigerators and microwaves will not be available for lunches, so please plan accordingly. The Foundation will provide a daily snack for camp participants. Snacks will consist of fruits, veggies, crackers, pretzels, etc., and the snack schedule will be sent in advance. Campers may bring their own snack if they have dietary restrictions.
- Camp sessions run from 9am to 3pm, Monday-Friday. Camp participants should not arrive before 8:50am. All camp participants are to be picked up promptly at 3:00pm (unless registered for after care until 5pm). In case of late pickup, emergency contacts will immediately be contacted. Camp participants will not be released to any person who is not listed under the emergency contacts. Proper picture ID will be required for anyone picking up a camp participant. An additional fee of \$25 per occurrence will be due for any camper who is picked up after 3:10pm (or 5:10pm if registered for after care).
- Camp participants who bring cell phones with them to camp should expect to use their phones only to contact parents in case of an emergency, or to take photos when given permission to do so. Calling or texting during camp activities will not be permitted.
- The St. Louis Aquarium Foundation is not responsible for lost or stolen items.
- All camp participants are expected to display safe, respectful, and appropriate behavior at all times towards staff, volunteers, guests, other camp participants and animals. Behavior guidelines and expectations will be reviewed with camp participants on the first day of camp. If a camp participant is consistently unable to abide by these expectations and guidelines, he/she/they may be dismissed from camp for the day or for the remainder of the camp session. The Foundation reserves the right to deny participation to any camper who exhibits unsafe behavior with staff, camp participants or animals at any time.
- Camp fees are not prorated if a camper leaves camp early or misses a day. If you cancel your registration more than 30 days before your camp session, a refund will be issued minus a \$50 administrative fee. Cancellations less than 30 days before the start of your scheduled camp session will not receive a refund. If a camp session is canceled by the Foundation, your fee will be refunded in full.
 - Partial, pro-rated refunds will be offered to campers who aren't able to attend due to covid-19 exposure.
