HOW DO I REGISTER?

The deadline to register and be eligible to vote in the November 3, 2020 election is October 5, 2020. This can be either the postmark date or the date the application is received in the office of the voter registrar. You may, of course, register at any time before that date to ensure that your registration is effective for voting in July. You can obtain a voter registration application from your voter registrar's office, libraries, most post offices, and high schools. You can also fill out a voter registration application online or request a postage-paid application be mailed to you. Note: If you fill out a voter registration application online using the above link, you must print the completed application and send it to your county voter registrar's office.

EARLY VOTING IN PERSON (October 13 through October 30)

Dallas County registered voters may vote at **any** early voting location.

- 65 years of age or older
- Out of the county during the entire election including early voting (Must provide an out of county address and the date to begin and the ending date of receiving mail at this address. This application is only good for one election and runoff.)
- Disabled
- Confined in jail, but eligible to vote. (This application is only good for one election and runoff.)

WHAT KIND OF I.D. WILL I NEED TO VOTE IN PERSON?

Here is a list of the acceptable forms of voter ID:

- Texas driver license issued by the Texas Department of Public Safety (DPS)
- Texas Election Identification Certificate issued by DPS
- Texas personal identification card issued by DPS
- Texas handgun license issued by DPS
- United States military identification card containing the person's photograph
- United States citizenship certificate containing the person's photograph or
- Passport

With the exception of the U.S. citizenship certificate, the identification must be current or have expired no more than 4 years before being presented for voter qualification at the polling place. Here is a list of the supporting forms of ID that can be presented if the voter cannot obtain, and has a reasonable impediment or difficulty to obtaining one of the forms of acceptable photo ID:

- Certified Birth Certificate (Copy or original)- a certified domestic (from a U.S. State or territory birth certificate or (b) a document confirming birth admissible in a court of law which establishes your identity (which may include a foreign birth document).
- Current Utility Bill (Copy or original)
- Bank Statement (Copy or original)
- Government Check (Copy or original)
