Following the lead of Indigenous communities around the country who have been fighting many of these battles for years on their treaty lands, and in response to COP26, GreenFaith is supporting efforts to

- pressure President Biden to use his executive powers to stop or revoke pipeline permissions;
- pressure banks and financiers to stop investing in fossil fuel infrastructure and development.
- Many of us who are not Indigenous live on lands that are not our own. We acknowledge that we live on traditional territories of First Nation peoples. I live on land of XXXX people. [learn more here.]
- We are reminded that we seek to live in respect, peace and right relations and we are mindful of broken covenants and promises made to and with indigenous peoples. By making a land acknowledgement we are honouring the land and Indigenous heritage which dates back over 10,000 years and continues still. Without the gifts of the earth we would perish. Let us remember that we belong to the land and to each other. Thank you.

Before we do that, we need to prepare.

Before you call and as you write your email:

- Take a few minutes to think about a personal story or how this situation relates to you. (your spiritual, physical and yes, even financial health)
- Think about what this situation means to you as a person of faith.

#### Reflect on:

- Health Air quality, Asthma, COPD, etc.
- Green jobs in wind and solar
- Pollution disproportionately effects BIPOC and poor communities
- Transport is dangerous, pollutes groundwater near pipelines, pollutes natural areas, rural communities, and impacts the agriculture economy.
- Rising sea levels that would impact your town/city.

### Spiritual Grounding:

- As people of faith we recognize that continued use of fossil fuels are morally wrong as we degrade the planet and destroy habitat for people and other living beings.
- As a person of faith (or member of the xxx community), I am moved by deep compassion for the vulnerable, and to care for all creation of which I believe we are a part (or responsible to care for)
- Invite leaders to dig into their own faith traditions and find the scriptures, stories and teachings that call us to care for the planet and the most vulnerable and to use that foundation as the lens for decision making.
