  - c. 2018-2019 Approved Budget
  - d. Unit and council (if in council) presidents' signatures
  - e. A copy of applicants 2018/19 membership card
4. \*Awardees are required to submit a written report of their convention experience to Ninth District PTA no later than **Wednesday, May 29, 2019** Please include a copy of your convention registration with report (if awarded) and focus on the following areas: *Benefits derived from attending California State PTA convention, leadership skills obtained, leadership training that will be used to strengthen PTA involvement and workshops that were most beneficial to you.* **\*All grants will be funded as a check reimbursement to the PTA council or unit following the receipt of the completed convention report. No checks will be authorized to a person.**
