COVID Relief Plan

Here is an opportunity for all of our members to take action regarding the COVID relief plan:

The nearly \$2 trillion American Rescue Plan that President Joe Biden signed in March will send \$15.3 billion in assistance to California's K-12 schools. It will be by far the biggest of three relief acts that Congress passed in less than a year to combat the pandemic and the recession.

Click [here](#) to lend your voice to PTA advocacy regarding the U.S. Department of Education (ED) issuance of Interim Final Requirements for the American Rescue Plan Act Elementary and Secondary School Emergency Relief Fund (ARPA ESSER). **Deadline for this Action Alert is May 24.**

School Districts must create a plan for using the latest money and publicly share it by June 1. Your LEA must seek public comment on their plans. Now sometimes these things can be difficult to find but know that this is written into the law and is your chance to advocate for our children at the local level.

So here is your chance to get engaged if you have not already done so.

Check your school districts website to see what their ESSER plan is. While you are at it, see what is going on with the Local Control Accountability Plan or LCAP. Learning Continuity and attendance plan

Attend a school board meeting,

Sign up for advocacy alerts from National and California PTA,

Participate in our take action campaigns,

May California State Budget Revise

California State PTA is celebrating Governor Newsom's May revised budget proposal that makes significant investments in California State PTA equity and priority issues, fueled by unexpectedly large tax receipts.
