



BJANA ELECTION COMMITTEE (EC) ANNOUNCEMENT OF BJANA ELECTIONS JAN 2026 – DEC 2027

As per the BJANA By-laws, the election of members of the Association's Executive Committee for the period Jan 2026 - Dec 2027 will be held for "a team" that will consist of the positions listed in the table below. 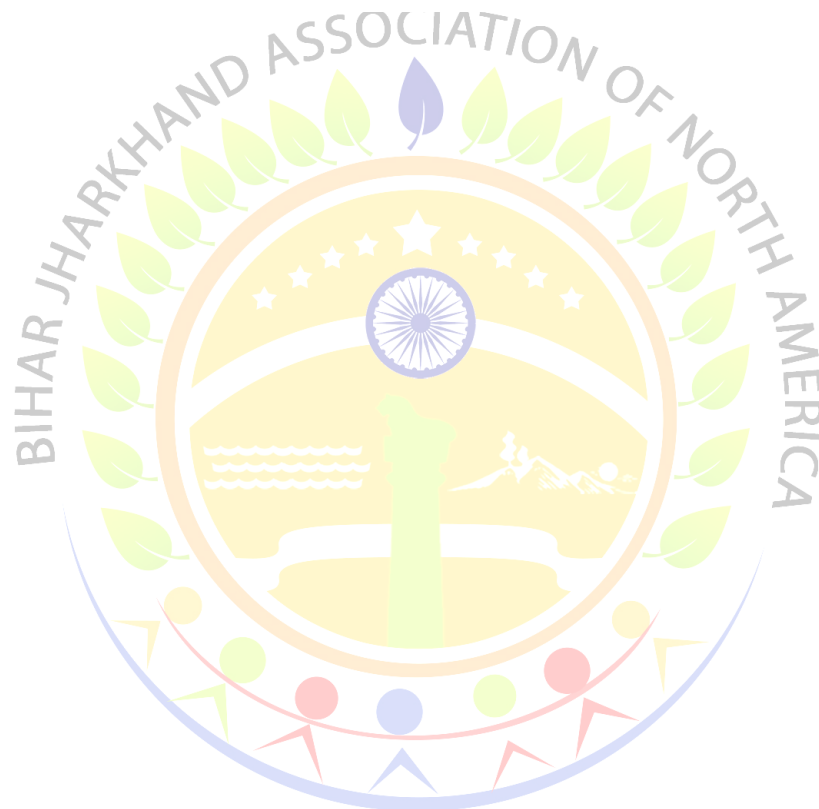

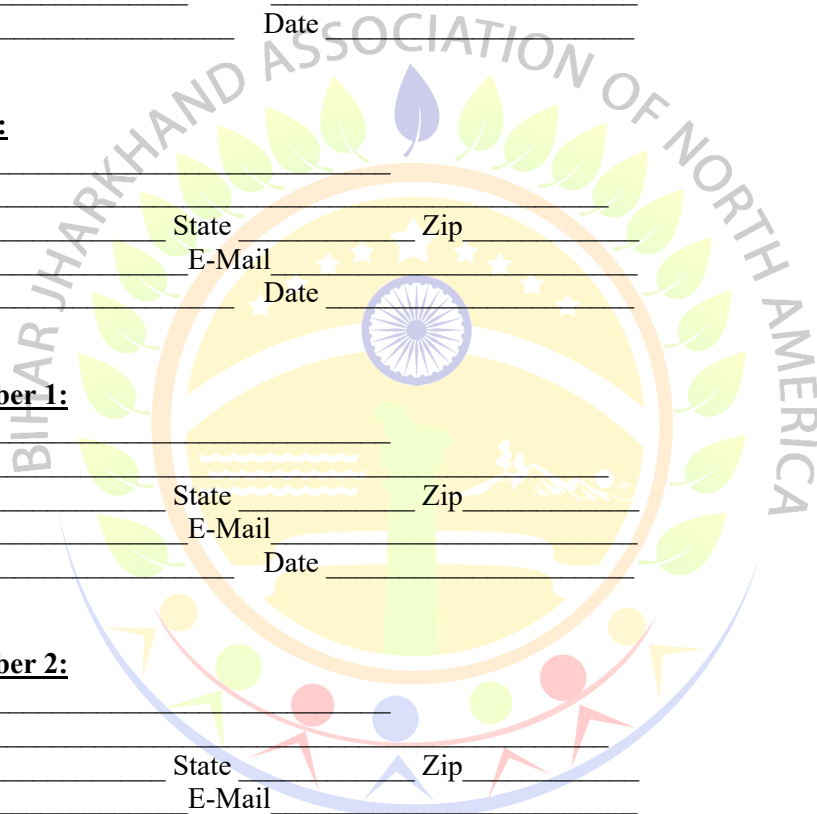
