As we reflect on the first half of the year, I am excited to share the progress we have made in developing new programs and initiatives to advance our community. Starting in July, our WIOA Youth program was transitioned in-house. To ensure a seamless and improved transition, we hired new staff and are exploring ways to enhance the program. In June, we had our first Youth Job Fair with over 400 youth in attendance.

Furthermore, we are collaborating with consultant David Shinder, to work on our strategic priority goals established by the Workforce Development Board (WDB). These goals include Promotion & Advocacy, Increased Coordination, Shared Prosperity, Business Engagement, and Fund Development. This partnership is crucial in aligning our efforts with these priorities to better serve our community.

I am thrilled to announce that, as of May 21, 2024, the Board of Supervisors approved the allocation of American Rescue Plan Act (ARPA) funds to support two new initiatives:

- 1. Stockton Chamber-Stockton Takes Action Against Retail Theft Program (STAART) and Security Camera Grant Program:** This initiative addresses the critical issue of retail theft, which has been significantly impacting our local businesses. The STAART program aims to mitigate these losses and support our business community in reclaiming their revenue and time.
- 2. Shop San Joaquin Program:** Utilizing BluDot Technologies, Inc.'s Open Rewards platform, this innovative mobile application encourages local shopping by rewarding consumers for their purchases at eligible businesses within San Joaquin County.
