This program will identify up to four TTA providers to identify these types of crimes and provide training on how investigations and prosecution should be handled, as well as on how communities can be made aware of their vulnerability to fall victim to these types of crimes. PREA Standard 115.53 requires confinement facilities to provide inmates with access to outside victim advocates for emotional support services related to sexual abuse.
