

# Substance Abuse Prevention and Treatment Block Grant Webinar Series for Block Grant-funded Substance Abuse Treatment Provider Organizations

## Overview of the Webinar Series

The Substance Abuse and Mental Health Services Administration (SAMHSA) allocates the Substance Abuse Prevention and Treatment Block Grant (SABG) for states to:

- Prevent substance use disorders (SUDs)
- Treat SUDs
- Promote public health

States, in turn, allocate SABG funds to subrecipients within their states. In the SUD treatment system, the subrecipients might include SUD treatment providers and/or intermediary organizations. Intermediary organizations include those that fund and manage treatment services throughout the state or within specific cities, counties, or regions of the state.

SAMHSA offers a range of consulting and training services and tools to help SABG-funded treatment providers and intermediaries adhere to the conditions for receiving those funds. So, this webinar series was designed with that purpose in mind. The series will increase provider and intermediary staff members understanding of the purpose and applicable requirements of the SABG. Descriptions of the four-part series follows.

## Session 1: Overview of the SABG Requirements

This session will provide the foundation for the four-part series and will offer SABG-funded provider and intermediary organizations an understanding of the following:

- The purpose and intent of the SABG
- The federal and state context for administering the grant
- What providers must, can, or shall not do regarding SABG funds and funded services

The session will include an overview of the following:

- The history, intent, and purpose of the grant and the process for allocating SABG funds
- Applicable fiscal requirements, including what maintenance of effort and set-aside funds are, restrictions on expenditures, revolving loan fund for recovery homes, and audit and subrecipient monitoring requirements
- Applicable service requirements, including those regarding priority populations, outreach, independent peer review, faith-based organizations, and independent peer review
