Minimum 3A license for pesticide applications recommended.

Duties:

Full-time attendance for 40 -48(negotiable) hours per week.

Employ & train employees to assist in proper daily maintenance

Keep full records and accounts for maintenance & operations for use of treasurer and of purchase and use of all chemical applications.

Obtain competent assistance & consultants in proper maintenance of greens, course, irrigation, equipment & repair.

Create proper rules and regulations for proper use of course equipment for safety of employees.

Work closely with the Club Professional, committees of the Club, Board of Directors, to insure profitable operation of the Club.

Compensation & Benefits:

The Club will provide worker's compensation, disability benefits and unemployment benefits as required by law.

Superintendent of Greens and Maintenance

The Battenkill Country Club in Greenwich, NY, Washington County established in 1925 is seeking a Superintendent of Greens and Maintenance. The position will serve a 300 plus member owned 9-hole golf course seeking innovation and management leadership to maintain and improve the existing facility.

RESPONSIBILITIES: The main function of the Superintendent will be the selection and management of employees to maintain grounds, facilities, and equipment outside the Clubhouse. He/She will work closely with the Club Professional and the Board of Directors to maintain and improve the golfing facility. The Supervisor will need to provide or be willing to receive training to provide the following services: maintenance of tees, greens and fairways, including application of pesticides, herbicides, fertilizers, and provide certification of or willingness to be certified for application. The Supervisor will be willing to supervise maintenance of golf carts (currently Club car 90% electric, 10% gas). The Supervisor will have an understanding of golf course watering system (currently Toro rainbird) and equipment to operate watering system.

QUALIFICATIONS: Applicants with a degree related to golf course management or maintenance are encouraged to apply. Applicants with golf course experience are also encouraged to apply. An applicant with experience as a golfer is a plus if he/she possesses the earlier qualifications. Current certification for pesticide and herbicide applications or willingness to obtain certification is a plus.
