| <b>Emergency Bushfire Response in Primary Industries Grants (Commonwealth/State support)</b> | <p>Grants of up to \$75,000 to assist primary producers directly affected by the 2019-2020 bushfire with recovery costs.</p> <p>Eligible activities include rebuilding or replacing damaged or destroyed on-farm infrastructure, including fencing and trellises.</p> <p>Wine grape growers who are located in eligible fire affected local government areas and have had crops affected by smoke taint may be able to claim for costs associated with the salvage, harvest and disposal of the smoke taint affected crops. | <b>Small Business Bushfire Recovery Grants (Commonwealth/State Support)</b> | Grants of up to \$50,000 are available for small businesses and non-profit organisations (who are not primary producers) that have suffered direct damage as a result of bushfire. | <b>Small Business Bushfire Support Grant (Commonwealth/State support)</b>   | Grants of up to \$10,000 to support small businesses (including primary producers) significantly affected by the 2019-20 bushfires to recover and rebuild resilient businesses.<br><br>Eligible activities include meeting standard business costs, seeking financial advice, adjusting the business to be viable in the changed local context following bushfire and improvements to make the business more resilient to future disasters.<br><br>You must be a small business owner or non-profit organisation and located within a <a href="#">specified Local Government Area (LGA)</a> and have suffered a decline in revenue of 40 per cent or more in a relevant three-month period.<br><br>Businesses can apply for this grant in addition to other bushfire grants. | For further information see: <a href="https://www.service.nsw.gov.au/transaction/apply-small-business-bushfire-support-grant">https://www.service.nsw.gov.au/transaction/apply-small-business-bushfire-support-grant</a><br><br>If you'd like assistance call <a href="tel:137788">13 77 88</a> .   |
