Guest Rules

Mercy HealthPlex welcomes you as a guest of our facility. We want you to have a fun and safe experience during your visit to the center. Our staff is available to answer any questions you may have concerning our programs, facilities, and equipment. We do require all guests to follow the rule of the center as listed below:

1. All Guests must sign an authorization and a release of liability form prior to using the Mercy HealthPlex.
2. A parent or legal guardian must accompany all guests between the ages of thirteen (13) through eighteen (18) and present an authorization and release of liability form signed by a parent or legal guardian prior to using the Mercy HealthPlex.
3. All visitors must pay the appropriate guest fee charge.
4. Fees will be charged for additional services such as childcare, personal training, massage therapy, swimming lessons, fitness assessment, exercise prescription, fitness orientation, tennis & racquetball court reservation fees, special classes and programs.
5. All guests are expected to wear appropriate attire when using Mercy HealthPlex. Shoes and shirts are required at all times in all areas outside the locker rooms and pool areas. Only non-marking, light soled athletic shoes, which will not mark courts, and exercise floors are permitted in these areas.
6. All guests are required to shower before entering the pools and whirlpools. Swimsuits are required when using pools, whirlpool, steam room, and sauna. Shaving is not permitted in whirlpool, steam room, or sauna.
7. All guests must use appropriate locker rooms. Children under the age of thirteen (13) are not permitted in the Men's and Women's locker rooms. The family locker room is available for use by the parent/guardian and child(ren) under the age of thirteen (13).
8. All guests under the age of thirteen (13) must be accompanied by an adult eighteen (18) years or older and must be within arms reach of the adult at all times. Guests under the age of thirteen (13) are not permitted on the exercise floor or allowed to use the equipment in the adult fitness areas.
9. All guests under the age of thirteen (13) are eligible to use the Kidsfit exercise areas and childcare services during their hours of operation. Appropriate fees will be charged for this service.
10. Guests are required to conduct themselves in a manner that is not offensive or harassing to other members/guests or staff of the Mercy HealthPlex.

I accept full responsibility for my use of any and all apparatus, appliances, facility privilege or service whatsoever owned and operated by Mercy HealthPlex and Mercy Health Partners, its trustees, directors, managers, employees, representatives, and agents harmless for any and all loss, claim, injury, or liability sustained or incurred by me resulting there from.
