**Prevention Council Statement on Ontario's Occupational Health & Safety Strategy &
CPO Retirement
July 2021**

Ontario's Prevention Council Chair released the statement below today:

1. Ontario's Occupational Health and Safety Strategy, Prevention Works

[Prevention Works, Ontario's Occupational Health and Safety Strategy](#), was published last week and we would like to congratulate our Chief Prevention Officer, Ron Kelusky on this accomplishment. Prevention Works demonstrates an overarching commitment to preventing injuries, illnesses and fatalities in workplaces across the province while building a system that is agile and collaborative.
