(b) Pictures of the working partnership on Stafford County Public Schools website.

(c) Organizational support throughout the partnership.

(d) Evaluation of the partnership as requested by either partner.

(e) Inclusion of the partnership in the Office of Strategic Communication and Community Engagement database.

6. Participation as a business partner does not entitle a business to advertise or distribute materials on SCPS property, or at SCPS events. Any and all advertising must meet SCPS policies and criteria concerning advertisements on school property. The School Board retains the exclusive right to authorize the use of its name, the names of its schools, and the corresponding logos, mascots and other similar information. The School Board must approve its identification as a partner in all publicity materials.
