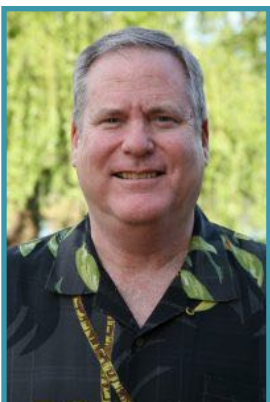
HONORABLE CURT HAGMAN
