Cash	Withdraw cash before the storm. ATMs may be down.

Flashlight	Don't forget batteries!	
Radio	dio  Get one that is powered with batteries or a hand-crank.	
Matches	Keep them in a waterproof container.	
Cell phone	Bring your charger and consider external batteries.	
Generator	Think about getting a portable generator, and don't forget the gas.
