


On March 10, 2021, President Biden approved the American Rescue Plan (ARP), which includes a Coronavirus Local Fiscal Recovery Fund of \$350 billion in emergency funding for state, local, territorial, and tribal governments. California cities are set to receive approximately \$8.4 billion, and in the following pages, we break down the projected allocations by city/town as of February 25, 2021. You'll also find a timeline and allowable and permitted uses for your ARP funding.

The Coronavirus Local Fiscal Recovery Fund is a chance for agencies to remedy the mismatch between rising costs and falling revenues from the pandemic. We certainly hope having this information will help your agency plan for just that.

CITIES WITH POPULATIONS GREATER THAN 50,000

The U.S. Treasury requires all federal financial assistance recipients—including cities with populations greater than 50,000—to have a Data Universal Numbering System (DUNS) number and an active registration with the System for Award Management (SAM) database at <u>SAM.gov</u>. However, acquiring a DUNS number and/or active SAM registration can take several weeks.

If your agency has a population greater than 50,000 (your agency is listed on pages 3-4), you should begin the process immediately. Taking these preparatory steps are free of charge and will better position your agency to receive ARP funds as quickly as possible.

Step 1: Ensure your agency has a valid DUNS number

The federal government uses a unique nine-character DUNS number to track how federal money is allocated. If your agency does not have a valid DUNS number, visit <u>FedGov.DNB.com/WebForm</u> or call 1-866-705-5711.

Note: A DUNS number is required prior to registering with the SAM database.

Step 2: Ensure the agency has an active SAM registration

SAM is the official government-wide database to register with in order to do business with the U.S. government. All federal financial assistance recipients must register on <u>SAM.gov</u> and renew their SAM registration annually to maintain an active status and eligibility to receive Federal financial assistance.

If your agency does not have an active SAM registration, please visit, <u>SAM.gov</u> to begin the registration or renewal process. Aside from your DUNS number, you will need to gather payment information, including:

- Entity Identification Number (EIN), name, and contact information
- Name and title of an authorized representative of the entity
- Financial institution information (e.g., routing and account number, financial institution name and contact information)

Note: SAM registration can take up to three weeks; delay in registering in SAM could impact timely payment of funds.



Note: Estimates use 2019 Census data to identify populations eligible for assistance, and do not include villages or other sublocal entities that may also qualify for funding. Identification of eligible governments and distribution of assistance across units with overlapping populations may reflect decisions made by the Department of Treasury and state governments.

ALLOWABLE USES

The legislation on how ARP funds can be used is brief, leaving much discretion to cities based on their unique priorities and budgets. It specifically states funds can be used for:

- Investments in infrastructure:
 - Facitlity modernization
 - HVAC, indoor air quality
 - Water
 - Sewer
 - Broadband
- Response to the public health emergency or its negative economic consequences
- Provision of premium pay to eligible workers
- Revenue replacement

PROHIBITED USES

There are two restrictions on the use of the fiscal recovery funds:

- State and local governments are prohibited from using the funds to make supplemental pension payments.
- The state cannot use ARP funds to directly or indirectly offset a reduction in net tax revenue through a change in law, regulation, or administrative interpretation. This restriction does not apply to local governments.

Each municipality will ultimately need to account for the funds expended and will need to provide periodic reports to the Treasury.
