We were 'busting at the seams' at our May Salad Supper where we recognized invited quests that included several new 2025/26 provisional members, friends of Christ Child who helped us in special ways this past year, and others who are interested in joining Christ Child this year. We thank Micki Trenta for coordinating the beautiful program honoring those who are celebrating anniversaries of 25, 30, 35, 40 45, 50, 55 and 60 years of membership. Thanks to all those who participated this past year in so many inspiring service projects, several of which are detailed in this newsletter, such as

the St. Augustine Library and the Clothing Center. In addition, we threw a baby shower for our Refuge Host Home new mom, chaired by *Mary Margaret Jakosh*. Vantasia and her family were very appreciative of the party and wonderful gifts supplied by our members.

A great thank you to Michelle Hathorn and Anne Stanton who chair Mary's Closet and Mary's Kitchen, which helped young moms clothe their toddlers and 25 young adults prepare for living on their own after leaving foster care, respectively. Our Layette program, led by Christiana Mastromatteo, Patty Smith and Carolyn Schmidlin, helped 315 moms receive a baby layette that would have cost each family approximately \$150-175 if purchased outright.

Tutoring at Crouse Elementary School, led by *Patty McClusky* and her team, continued to demonstrate to young children how the love of reading can serve them well all their lives. All of these projects were successful in helping Akron area children from infancy to adulthood because of the work, dedication and love shown by each of our members. It is such an honor to be a part of Christ Child Society of Akron!

Plans are underway for our Red Wagon Boutique and Luncheon to be held Nov. 22 at the Hilton-Double Tree and there are all sorts of ways that each of us will be able to help. Continued on page 6

St. Augustine Library

The library at St. Augustine School in Barberton was staffed two days a week by Meg Lee, Beth Vass, Rita Burkley and Kathy Kuebel. Other volunteers came to assist as needed. Regular volunteers included Micki Trenta, Laura Beringer, Cheryl Fuhrer, Linda Herberger, and Anne Simmons. Volunteers are required to have a background check and complete the VIRTUS training in order to volunteer.

We again worked with Tracy Varner from SWOCA (Southwest Ohio Computer Association) who assisted us when concerns arose. They support the technology side of operating a library – inputting ordered books, barcodes for students and books, as well as inventory etc. Unfortunately for us, Tracy is retiring, but she has left us in the capable hands of NEOnet (Northeast Ohio Network for Educational Technology). They are similar to SWOCA only more focused on our geographic area. The cost of their services is \$3.10 per student per year. SWOCA charged \$3.00 per student. St. Augustine has paid for that service for the past two years. We ended the year with 197 students, 14 more than the previous year. The projection for next year is 210 students.

The Library at St. Augustine School was fully up and running at the beginning of the 2024/25 school year. We did have to order another shelving unit as we have added hundreds of new titles to our inventory.

The library hosted two book give-aways this year. Each time the students were allowed to select a book from a variety of titles. To make the last book give-away even more special, we drew a name of a boy and a girl from the K-5 classes who visit the library as a group. Each received a fleece blanket because we all know how wonderful it is to cozy up

The library at St. Augustine School in Barberton was with a blanket and a good book. A teacher was also staffed two days a week by *Meg Lee, Beth Vass, Rita* selected to receive a blanket.

To prevent loss, we tried something new with Kindergartens this year. We asked that the books they checked out from the library be kept at school. Each week we provided them with an inexpensive book for them to take home. It really helped and our losses were down considerably this year.

Each week Meg, Beth and Rita provided programing around holidays, celebrations, current events, reading skills or literacy skills during the students' library time. The students seemed to immensely enjoy their library time. It was great to watch them ask for certain books, recommend books to friends, and show an even greater appreciation for the library compared to last year.

Reading scores for St. Augustine also indicate an increase in reading skills. The school academic growth percentile went from 45 in 2023/24 to 47 in 2024/25. This score measures how much a student has improved over time compared to other students with similar starting scores. In this case it means that the students' growth was higher than 47% of their academic peers. The goal at St. Augustine this year was to at least reach a percentile score of 50. They were short of the goal, but gaining on it.

Since we started the library, we have enjoyed the support and encouragement of Scott Embacher, Regional Director of Notre Dame Ace Academies-Akron. Unfortunately, Scott will be leaving us as he has taken a new position. He will surely be missed. McKenna Corrigan will be taking his place.











Clothing Center

The Clothing Center Program has wrapped up the work for the 2024/25 school year.

Chairs, Kathy Kuebel, Patty McCluskey and Mary Barnes, printed the orders and pull needed items from our inventory. Packing orders were done by a small group of members on an asneeded basis.

Jo Spurlock left the Akron area and we are so grateful that Kathy McCarron stepped in to be our buyer this year. She has done an awesome job!

Deliveries were managed again by *Judi Hill* and *Barb Neman* with volunteers rounding out their teams.

We ended the year providing clothing for 994 students in need in the Akron area. Of that total 677 were for Akron Public School students, 317 from charter schools, and 18 from Catholic schools.

We again offered a paper shoe voucher with a \$60 value at J.C. Pennny's in

Montrose. Students used 234 vouchers. Project RISE, a subcommittee of APS that works with unhoused students made us aware that transportation is often a problem for their families. This is our third year of having an on-line shoe voucher option for them. The shoes are sent to us and then delivered to the school by our delivery team. This year 297 pairs of shoes were ordered for Project Rise students.

We have been fortunate enough to receive some generous donations again this year including:

Gourmet Group

Christ Child's Gourmet Group members sampled the varied cuisine of "P" country Peru in May. Peruvian cuisine reflects local practices and ingredients including influences from the indigenous population, for example Andean and Amazonian cuisine, as well as cuisines brought by immigrants from Europe (Spain and Italy), Asia (China and Japan), and Africa (Maghrebi and West Africa).

Without the familiar ingredients from their home countries, immigrants modified their traditional cuisines by using ingredients available in Peru. Due to its long multicultural history, Peru is considered an example of fusion cuisine.

May hosts were Loretta and Darryl Fieldman, Laura and Mike Hannah, Mary and Peter Leahy, Martha and Dan Mosher, and Jackie and Mike Sonderman.

A Peruvian cocktail, Pisco Sour, was served at some dinners. Appetizers Included Ceviche, either made with Shrimp or Sea Bass, and served with Tortilla Chips. Other starters were Garlic and Herb Roasted Shrimp, and Stuffed Dates with Bacon.

For the main course, Stews were popular, including a Chicken Stew with Vegetables, and a Pork Stew with Chilies, Lime, and Apples.

One dinner featured Fettucine with a Pepper/Cheese Sauce and Grilled Chicken. Another dinner featured Peruvian-Style Grilled Chicken with a Spicy Green Sauce.

Side Dishes included Cucumber Salad, Roasted Potatoes, Potatoes in a Cheesy Pepper Sauce, and Corn, Bean, and Cheese Salad. Luscious Desserts included Flan with Fresh Berries, Suspiro al la Limena, Tres

Leches Cake, and Peruvian Lemon Pie.

All CCS members and partners can be a part of Gourmet Group. Gourmet Group members pay dues of \$20 and sign up each year in July to attend four themed meals during the year, in October, January, March and May.
