Health Management – Leaders in Health Services

2 Days

Description

As part of comprehensive health services, every Head Start program must provide services to promote health, behavioral health, and safety for children and families. New and experienced health services staff can use resources to learn more about health services and the role of health services staff. This course is designed for two days of in-depth training and also includes professional development resources for health services staff, child care health consultants, and others who support health services across all early care and education settings. This two day course is an action plan to help health managers determine what needs their attention, how to structure their work, and ways to continue to grow and learn. The course is based on the core areas of health and behavioral health. Each lesson will begin with a list of applicable rules, regulations, guiding standards, and considerations related to social determinants of health. Managers will learn about the Health Competencies and how they can use the competencies to learn more about the attitudes, knowledge, and skills needed to deliver high-quality health and safety practices. Leaders will learn there will be some competencies where one excels, and others where one may benefit from continued learning. Developing staff's skills in many categories will help Health Managers to manage their Head Start health services. Managers will learn how to use these competencies to hire, develop, and keep qualified staff. Health services managers and staff, supervisors, and program directors will learn to use the competencies as the most important ways to keep children, families, and staff healthy and safe. Health leaders and staff can also use the competencies to identify their areas of strength and areas for improvement. Leaders participating in this course will improve the ability of the staff and the program to offer high-quality early childhood health services and help children and families achieve positive health outcomes. Managers will learn how to use the competencies to: Explore values and ideas about health care practices, Examine how to talk to families about health topics, Hire and supervise health services staff and Create individualized professional development plans for health staff. The course includes actionable tips and strategies for the health manager and considerations related to trauma. It also features tips and resources that support professional development for health managers and staff, as well as collaboration with families. Programs may choose to incorporate all or part of this course into professional development activities based on their staff interest and needs. Some information learned may also be useful to other program staff, including managers, education staff, family advocates, and transportation staff.

Who Should Take This Course?

This course is for anyone responsible for the management and oversight of health services across all Head Start settings. In many programs, the person primarily responsible for this is the health manager; in some programs, they are called health coordinators, specialists, or directors of comprehensive services. Often, there is a team of people who work together to manage health services. This Health Manager course provides a foundation for new health managers and features updated information and resources for health managers who have been in the role for a while.
