What is an HSU License?

Our **license** is a “**permission to practice.**” Our license program is an academic career advancement program and a 36 week training curriculum. The program is designed to convert to college credits for higher education degrees. Students who are enrolled in our license program are building a transcript that can be used to meet their academic requirements or professional licensing requirements. As an education partner with over 50 universities around the US, HS University can offer education and professional development courses targeted for the best benefit for meeting Head Start professional development needs. We have aligned with each university partner a curriculum that is designed to meet Head Start competency standards as well as the academic credits that will transfer to college credits or continuing education units (CEUs). Our license programs have a student practicum that is matched to real Head Start situations so students can use strategies learned in their practicum for their current positions to maintain compliance and program service quality. HS University cuts program's professional development cost by building on credentials already earned. Credit for previous credentials will require a Prior Learning Assessment (PLA) to be completed. - **Step 1: Complete Application...** Complete the enrollment application and pay enrollment fee. This starts your journey into our license program.
- **Step 2: Attend Training...** Next find the right training method that best fits your learning style and schedule. HS University offers classroom training, online classes, and LIVE Online. Training presented the way you want to attend. You decide the best method of training based on program, personal and your family requirements.
- **Step 3: Complete a 6-week Online Train the Trainer Course..** The next thing is to attend a six week online train the trainer course. Online course requires student to login twice weekly to post discussion questions and post assignments.
- **Step 4: Complete Exams...** Then, schedule to take your exams. Each license requires a certain number of exams passed in order to complete the program. **License** requires the completion of **two (2)** exams and a in-person presentation video.
- **Step 5: Complete Practicum and Field Work...** Students must complete an 120 clock hour practicum designed to ensure each student has supervised practical application of currently studied content area.
- **Step 6: Complete Self-Appraisal form, Portfolio Packet and Prior Learning Assessment and award process...** Portfolio packets are completed to determine education and work experience for CECs. These items are used to examine prior learning assessment for re-certification.



What is a management license?...

A management license is a “collegiate diploma.” It is a post secondary academic process of establishing the qualifications of

skilled professionals in Head Start programs. The management license focuses on the importance of management quality and demonstrates how the achievement of quality management services depends on shared Head Start values and an exemplary management team. Students enrolled at this level will examine the characteristics of management and training skills and techniques such as personal effectiveness, stress management, creativity, problem solving, and program improvement that produce managers that contribute to the rigorous and relevant dimensions of planning, organizing, influencing and evaluating in the Head Start community.

A management license is a permission granted by HS University to engage in Head Start community’s development through consulting, employee training, credentialing and development and other professional outreach activities. A management license is an advance educational certificate and can be used toward core requirements of professional degrees. This process is inclusive of the supervisor credential program but provides contribution to the management development of the Head Start community through rigorous and relevant systems of management. Graduates are nationally recognized for the information they publish in premier management papers and journals. Program completion usually takes **36 weeks** to complete.

License Cost starting at \$3195.00!

Each license includes the following cost:

- **Application Fee** —Candidates seeking a credential must complete the candidate’s application/assessment and pay the application fee. Application fee is \$485 per person.
- **Training**—candidates must attend three required training courses. 2-day/6 week course, supervisory course and trainer course for \$1585 (A 20% discount)
- **Take Exams**— A license has two exam requirements. Exams are \$185 per exam. Students must pass exams. Exam fees are non refundable.
- **Coursebooks**—Candidate must purchase the appropriate required books to participate in each program. Course book cost can be up to \$635 per coursebook.
- **Student Practicum** —The Student Practicum is a specialized field of study, that is designed to meet 120 hours of students practical hands on field work experience. Cost: \$695
- **Technology Fee** —Candidate must participate in online discussion via Blackboard Learn™ and receive regulatory updates and information. Technology fee is \$395 per person.
