

Substance Use Disorders (SUDs) and Medication Assisted Treatment (MAT) for Opiates

STEP 1

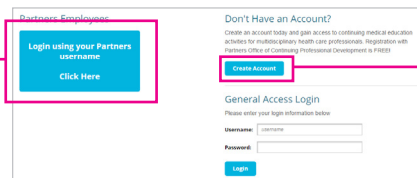

Partners Employees click on this blue box to create an account.

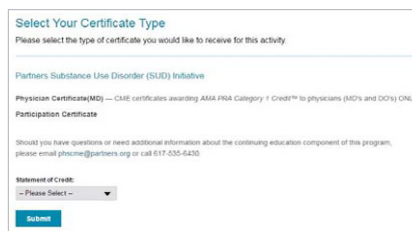


All other users click on "Create Account."

Activity Overview and CME Information:

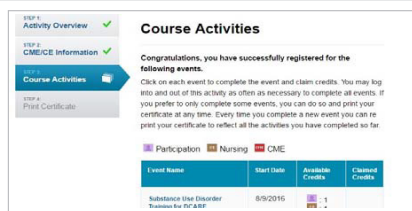
Click on Next at the bottom of the "Activity Overview" page and the "CME Information" page.
