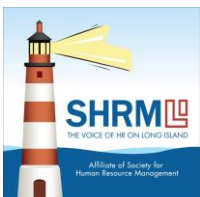

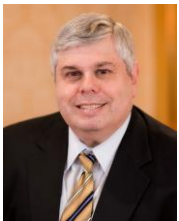

According to federal judicial caseload statistics, wage and hour filings have increased by over 450% in the last 15 years. In contrast, aggregate settlement amounts for wage and hour class actions have been dropping, from 695.5 million in 2016, to 525 million in 2017 and 253.5 million in 2018. So, where are we headed? What are we seeing on Long Island? What takeaways can we give to employers regarding their wage and hour compliance efforts?
