UPPER SAN JUAN HEALTH SERVICE DISTRICT RESOLUTION (No. 2020-27) FOR

SUPPLEMENTAL BUDGET and APPROPRIATION

(Pursuant to Section 29-1-109, C.R.S.)

A RESOLUTION APPROPRIATING ADDITIONAL UNANTICIPATED REVENUES TO DEFRAY EXPENSES IN EXCESS OF AMOUNTS BUDGETED FOR THE UPPER SAN JUAN HEALTH SERVICES DISTRICT ("USJHSD").

WHEREAS, in 2020, USJHSD responded to the COVID-19 worldwide pandemic and as a result had unanticipated expenses for the pandemic response including personal protective equipment, supplies, equipment, staffing, infection control facility renovations as well as unanticipated revenues (all from sources other than property tax revenue) for the pandemic response.

WHEREAS, USJHSD had unanticipated expenses and revenues in the amounts described on the attached Schedule 1, incorporated into this Resolution 2020-27, all of which could not reasonably be foreseen or known in November 2019, the time of the Board's adoption of the 2020 budget.

NOW, THEREFORE, THE BOARD FOR THE UPPER SAN JUAN HEALTH SERVICE DISTRICT RESOLVES AS FOLLOWS:

That the 2020 appropriation for the USJHSD general fund is hereby increased from \$48,188,658 to \$50,612,107.50 for the purpose of addressing the COVID-19 pandemic.
