STAFF REPORT TO THE BOARD OF DIRECTORS OF THE UPPER SAN JUAN HEALTH SERVICE DISTRICT d/b/a PAGOSA SPRINGS MEDICAL CENTER APRIL 11, 2024

FACT INFORMATION REGARDING THE MEDICAL WELLNESS BUILDING ("MWB"):

1. For 2024, the Board approved a grand total of \$4,689,513 for *all* 2024 capital projects funded from the following sources:

a. Grants: \$2,253,488
b. Donations: \$825,000
c. "PSMC Funding": \$1,611,025

- 2. Included in the 2024 capital budget was a placeholder sum of \$1,650,000 for the renovation of the Medical Wellness Building (at the time the Board approved the 2024 budget, PSMC did not have a Guaranteed Maximum Price for the renovation of the Medical Wellness Building).
- 3. PSMC has received the Guaranteed Maximum Price ("GMP") for the renovation and additional expenditures as well as staff's proposed owner contingency for the MWB project as follows:

• GMP for the renovation: \$1,831,945

• Additional expenditures:

Parking lot replacement: \$350,000
Fiber to serve the MWB: \$25,000
Electrical (transformer, lines, panels): \$60,000
Furniture/patient tables: \$50,000

• Owner contingency (if needed, for unknown issues that may arise): \$210,000

Total: \$2,526,945

4. The GMP for the renovation, the additional expenses and the proposed owner contingency exceed the \$1,650,000 amount planned in the capital budget by \$876,945. As a reminder, PSMC received substantial funding to be used for the MWB renovation including \$1,000,000 of grant funding from DOLA and \$488,045 (available to date) from donations made to PSMC's Foundation.

RECOMMENDATION OF PSMC STAFF:

PSMC staff recommend to the Board the following actions:

- Approve the renovation Guaranteed Maximum Price, the additional expenditures and owner contingency set forth above; and
- PSMC expenditures in 2024 for projects will not exceed the \$1,611,025 amount of "PSMC Funding" originally approved by the Board. PSMC staff will meet the PSMC Funding budget through a combination of: (a) deferring other planned capital expenses to another year; (b) raising more capital funds from donations, and/or (c) raising more capital funds from grants; and
- Request the Foundation to provide to PSMC the \$488,045 it has available for the MWB project.
